

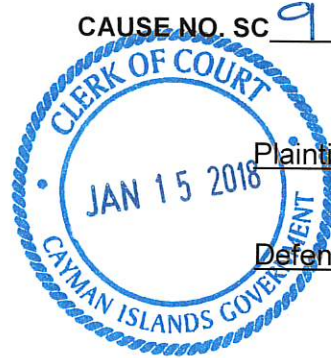


## PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

- 1 The Defendant rented a motor vehicle from the Plaintiff on October 24 2017 and a contract was signed to the agreement of the Rent a Car.
- 2 The M/V was returned on 15 November 2018 and at the time the Defendant had a outstanding balance of \$915.12.
- 3 The Defendant gave the Plaintiff his CNB bank card to take payment for the said M/V on the 21 November 2017 after trying 21 times the bank card declined all.
- 4 After numerous phone calls to the Defendant, the defendant made promises to start making payment, after no payment was received from the defendant the plaintiff called the defendant only to discover that the defendant had blocked the plaintiff from placing any calls to him
- 5 On 1 December 2017 the outstanding balance was handed over to our debt collectors to collect on the plaintiff behalf and a payment of \$150.00 was made.
- 6 The debt collector made several phone calls to the defendant who promised to pay \$200.00 starting 15 December 2017 he failed to do so and the debt collector also discovered that the defendant turned off his phone.
- 7 As of January 15, 2018 the Defendant owes the Plaintiff \$1,065.12

AND the Plaintiff claims:

- (1) The sum of \$1,065.12
- (2) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Total sum \$1,365.12.
