1. The Plaintiff is a Bank carrying on business at its branch at Elgin Avenue, PO Box 1097, George Town, Grand Cayman KY1-1102 and elsewhere, and the Defendant is and at all material times, has been a customer of the Plaintiff at the said branch.
2. The Defendant is currently indebted to the Plaintiff in respect of a chequing account ending #14642 in the principal sum of CI\$11,938.03, plus interest which will continue to accrue at the rate of 13.25% with other fees and overdrawn charges added every 15 days.
2. The Plaintiff demanded payment of the debt due by a letter from its attorneys dated 12 December 2017. The Defendant has failed to pay the debt due to the Plaintiff.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the said sum of CI\$11,938.03;
2. Interest on the above principal sum at the rate of 13.25%, and continuing until payment at the same rate pursuant to the Plaintiff's standard banking terms and conditions.
