If you intend to contest the action in whole or in part, you must set out full particulars of your defence in the space provided in the Acknowledgment of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgment of Service form containing full particulars of your defence, the Plaintiff may apply for a Default judgment without further notice to you.


PARTICULARS OF CLAIM

1. The plaintiff is at resides at #44 Randyke Gardens, George Town, Grand Cayman.
2. The defendant is a resident of West Bay, Grand Cayman, Cayman Islands.
3. In or around June 2017, the plaintiff loaned the sum of CI\$1,000.00 to the defendant who promised to repay the full amount to the plaintiff within 30days of the loan.
4. That the defendant paid the plaintiff CI\$200.00 towards his indebtedness to him but did not make any further payments leaving the balance of CI\$800.00 unpaid.
5. That despite demands for the payment of this sum by the plaintiff and his attorney, the defendant has failed/refused to repay the said balance of CI\$800.00.
6. As a result of the defendant's failure/refusal to pay, the plaintiff has suffered loss and damage and seeks and is entitled to the relief sought.

WHEREFORE THE PLAINTIFF CLAIMS FROM THE DEFENDANT

- a) Damages in the sum of CI\$800.00
- b) Fixed costs of CI\$150.00 plus filing fees or costs to be assessed.
- c. Pre- and Post Judgment interest from July 1, 20187 to date of full payment at the prescribed rate of 2 3/8% per annum pursuant to the Judicature Law (2013 Revision) and the Judgment Debts(Rates of Interest)Rules, as amended from time to time
- d. Such further and/or other relief as the Honourable Court deems just.
