PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

1. The Defendant was issued a loan of CI\$300.00, on the 9/3/2017, with a two-week pay back term. Her original interest was for CI\$90.00
2. In accordance with her signed contract the payment terms have not been met by the defendant, therefore we hereby apply for the courts intervention in seeking a resolve to this matter.
4. She now owes the amount of CI\$2110. The Defendant has paid a total of \$170.00 thus far and that was reduced from the sum being sued for. All attempts to get her to pay off her debt has been futile.
5. The sum owed was reach by doing the following calculations. (compounded amount x interest amount x contracted payment period + full compounded amount). The Defendant's total being sued for is gratefully reduced in order to assist her in making payments.

Her loan is calculated as follows:

$4 \times 15 \times 2 = 120 + 30 = 150 = 550$ / $5 \times 15 \times 2 = 180 + 550 = 730$ / $7 \times 15 \times 2 = 210 + 30 = 240 + 730 = 940$
 $9 \times 15 \times 2 = 270 + 30 + 300 = 330 + 940 = 1240$ / $12 \times 15 \times 2 = 360 + 30 = 390 + 1600$ /
 $16 \times 15 \times 2 = 480 + 30 = 510 + 1600 = 2110$ this loan was capped as of June 2017.
