PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

1. The Defendant was issued a loan of CI\$500 on; 19/5/2017, with an original due date for 1/6/2017. Payback interest total was CI\$150.00.
2. In accordance with her signed contract the payment terms have not been met by the defendant, therefore we hereby apply for the courts intervention in seeking a resolve to this matter.
4. Several attempts, using various debt collection resources have been applied, to collect the outstanding reduced amount owing of CI\$5500, yet none have resulted in the defendant coming in to honour her debt.
5. The sum owed was reach by doing the following calculations. (compounded amount x interest amount x contracted payment period + full compounded amount)

$6 \times 15 \times 2 = 180 + 30 + 650 = 860$ (Unpaid, carried forward)

$8 \times 15 \times 2 = 240 + 30 + 860 = 1130$ (Unpaid, carried forward)

$11 \times 10 \times 2 = 220 + 30 + 1130 = 1380$ (Unpaid. Reduced compounded amount carried forward)

$13 \times 10 \times 2 = 260 + 30 + 1380 = 1670$ (Unpaid, carried forward)

$16 \times 10 \times 2 = 320 + 30 + 1670 = 2020$ (Unpaid, carried forward)

$20 \times 10 \times 2 = 400 + 30 + 2020 = 2450$ (Unpaid, carried forward)

$24 \times 10 \times 2 = 480 + 30 + 2450 = 2960$ (Unpaid, carried forward)

$29 \times 10 \times 2 = 580 + 30 + 2960 = 3570$ (Unpaid, carried forward)

$35 \times 10 \times 2 = 700 + 30 + 3570 = 4300$ (unpaid, carried forward)

$43 \times 10 \times 2 = 860 + 30 + 4300 = 5190$ (Unpaid, carried forward)

$51 \times 10 \times 2 = 1020 + 30 + 5190 = 6240$. This amount was capped and reduced to \$5500. This total was reached as of 30/10/2017.

And the Plaintiff claims:

- 1 The principal sum of \$ 500.00
- 2 Interest in the sum of \$ 5000.00 calculated at the prescribe rate from _____ to date.
Interest to continue until the matter is settled.
- 3 Fixed costs of \$ 150.00, alternatively costs to be assessed.
