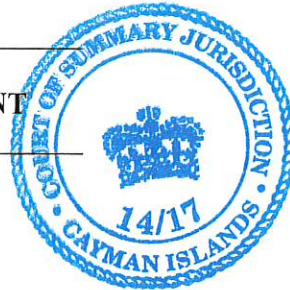

If you intend to defend this action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the Acknowledgement of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff is a Bank carrying on business at its branch at Elgin Avenue, PO Box 1097, George Town, Grand Cayman KY1-1102 and elsewhere, and the Defendant is and at all material times, has been a customer of the Plaintiff at the said branch.
2. The Defendant borrowed money from the Plaintiff under a loan account which, subsequently fell into arrears.
3. On 19 July 2016 Defendant signed a re-payment agreement with the Plaintiff pursuant to which she agreed to make monthly instalment payments of CI\$250.00 commencing on the 26 August 2016. Since then, only three payments have been received totaling CI\$640.00. The Defendant is therefore in default of the 19 July 2016 agreement.
4. The Defendant is currently indebted to the Plaintiff in the principal sum of CI\$10,835.09. Interest on the said debt has been charged off.
5. Accordingly the Plaintiff demanded payment of the debt due by a letter from its attorneys dated 05 December 2017. The Defendant has failed to pay the debt due to the Plaintiff.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the said sum of CI\$10,835.09;
2. Costs.
