PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

1. The Defendant was issued a loan of CI\$300.00, on the 24/11/2017, with a four-week pay back term. His original interest amount was CI\$180.00
2. In accordance with his signed contract the payment terms have not been met by the defendant, therefore we hereby apply for the court's intervention in seeking a resolve to this matter, since all other actions thus far has proved futile.
4. He currently owes the sum of CI\$1830. The Defendant has displayed debt intent forethought, when he uttered that he will not honour his debt.
5. The sum owed was reach by doing the following calculations. (compounded amount x interest amount x contracted payment period + full compounded amount). The Defendant's total being sued for is gratefully reduced in order to assist her in making payments.

His loan is calculated as follows:

As of 14/12/2017 his balance was \$435.00
 $4 \times 15 \times 5 + 435 = \735.00 (14/12/2017 – 17/1/2018)
 $7 \times 15 \times 4 + 735 = \1155.00 (17/1/2018 – 15/2/2018)
 $11 \times 15 \times 4 + 1155 = \1815.00 (15/2/2018 – 22/3/2018)
Late and roll over fees: \$15.00
And the Plaintiff claims:

- 1 The principal sum of \$ 300.00
- 2 Interest in the sum of \$ 1530.00 calculated at the prescribe rate from 24/11/17 ~~15/2/18~~ to date.
Interest to continue until the matter is settled.
- 3 Fixed costs of \$ 150.0, alternatively costs to be assessed.
