1. The Plaintiff is a Bank carrying on business at its branch at Elgin Avenue, PO Box 1097, George Town, Grand Cayman KY1-1102 and elsewhere, and the Defendant is and at all material times, has been a customer of the Plaintiff at the said branch.
2. The Defendant is currently indebted to the Plaintiff in respect of a Unsecured Loan Account in the principal sum of CI\$7,395.30, plus interest which will continue to accrue at the rate of 10.50% per annum until payment. The arrears amount to CI\$3,610.00. The Unsecured Loan Account is repayable on demand.
3. The Plaintiff has made written demand for payment of the arrears on the Unsecured Loan Account by letter dated 16 March 2018 and served on the Defendant on the 21 March 2018 from its attorneys but the Defendant has failed to repay the said sum. The Plaintiff now seeks repayment of the full amount now due under the Commercial Chequing Account.
