PARTICULARS OF CLAIM

1. The Defendant was issued a loan of CI\$300.00, on the 2/1/2016, with a two-week pay back term. Her original interest amount was CI\$90.00 to be paid on 15/1/2016

2. In accordance with her signed contract the payment terms have not been met by the defendant, therefore we hereby apply for the court's intervention in seeking a resolve to this matter, since all other actions thus far has proved futile.

4. She currently owes the sum of CI\$2000. The Defendant has gotten many chances, to pay including a drastically reduced amount for payment, yet she keeps giving varying dates for payments that never materialized.

5. The sum owed was reach by doing the following calculations. (compounded amount x interest amount x contracted payment period + full compounded amount). The Defendant's total being sued for is gratefully reduced in order to assist her in making payments.

Her loan is calculated as follows:

Period ending December 2016: Balance \$2000 (Reduced amount)

Period ending December 2017. Balance \$2000 (Reduced amount)

Period ending 14/April/2018: \$2000 (Reduced amount)

And the Plaintiff claims:

- 1 The principal sum of \$ 300.00
- 2 Interest in the sum of \$ 1700.00 calculated at the prescribe rate from 2/1/16 to date.
Interest to continue until the matter is settled.
- 3 Fixed costs of \$ 150.00, alternatively costs to be assessed.
