PARTICULARS OF CLAIM

1. The PLAINTIFF is an ordinary Cayman Islands company
2. Pursuant to various written agreements entered into between the Defendant and the Plaintiff and Lewis Ebanks on 09th May 2018, the Defendant promised to pay Lewis Ebanks CI\$7,500 on Thursday 10th May, 2018 as repayment for costs incurred
3. The Defendant failed to make payment on the due date (10th May), and despite numerous demands to do so has failed to comply. Further, the Defendant has indicated that he will not be honouring the Agreement and continues to refuse to pay

THE PLAINTIFF claims:

1. The Sum of CI\$7,500 (Cayman Islands Dollars, Seven Thousand Five Hundred);
2. Interest at the rate of 10% per annum, continuing at the daily rate of CI\$2.05, from the due date of 10th May, 2018;
3. Costs; and,
4. Such further relief as this Honourable Court deems appropriate

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed of CI\$7,500 (plus interest and costs) further proceedings will be stayed. The money must be paid to Lewis Ebanks.
