- 5 As of Tuesday May 29 2018 no contact has been made and as such:
- 6 As of May 29, 2018 as per contract the Defendant as per contract owes the Plaintiff \$644.00

- (2) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (3) Total sum \$944.00.


