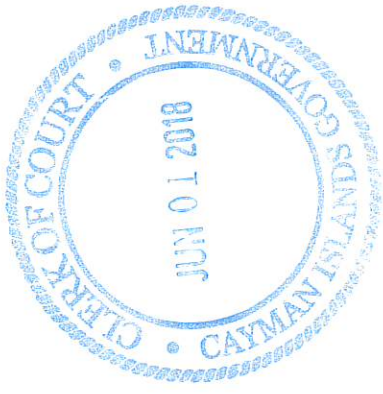

PARTICULARS OF CLAIMS

- 1) On the 15<sup>th</sup> 2017 I requested a Report from the Royal Cayman Islands Police Service for an Application for a Traffic Accident that had occurred, date of accident was 18/8/2017 Vehicle Req # Q2006 from investigating officer P.C. Carmile Haughton, the Location of Accident was on Martin Drive. Marked Exhibit (1)
- 2.) On the 28<sup>th</sup> February 2018 I Jacqueline Marie Green seek legal Aid which was Granted and signed by the Director of Legal Aid 3<sup>rd</sup> February 2018, See attachments Marked Exhibit (2) a third party discharge form without prejudice settlement stated. I hereby certify that the above mentioned person is authorized to seek and obtain legal advice and representative in respect of the proceeding or indented proceeding described above, subjected to the limitation and conditions specified.
- 3) Signature in which I signed dated 30 April 2018 witness by Lorin Williams dated 30<sup>th</sup> April 2018.
- 4) At no time was it agreed by me or no time agreed by both party's to subtract fees or cost from said sum of KYD 12,000.00, all bills was to be paid incur by the incident to be paid by me the said inclining hospital bills.
- 5) On the 9<sup>th</sup> of May 2018 I went the KSG Attorney CTD office to collect final settlement of KYD 12,000.00 dollars from James Kennedy at around 11am, in which he handed me a check of KYD 7,535.00 dollars #000453 Please see attachment Mark Exhibit # (3), he then took me into a conference room to sign a document in which I refused and said I must not come back to his office again, I went to the Bank but they refuse the check because of some type of error so I went back to his office to correct the check mark # 000453 in the amount of KYD 7,535.00 on the said day of May 9<sup>th</sup> 2018, to replace with check marked Exhibit (4) # 000457, that was the first time I saw a False document of said to be an agreement Mark Exhibit (5) by Mr. James Kennedy, this document I believe was Forge and not by me.

- 6) Mr. James Kennedy wrote a letter to the Immigration department asking for my extension for 6 weeks, in order for me to received my settlement from him.
- 7) The 9<sup>th</sup> of May 2018 he called me to collect my check in which he know it was my last day on Island and could not received my balance.
- 8) My Hospital bill has not been paid up to this date
- 9) Thanks to the help of Mr Braddy attorney at law in which I am still here to fight and had to pay the cost of KYD200.00 dollars.

11) The Plaintiff further claims interest on the said sum pursuant to Section 34(1) of the Judicature Law and Judgment Debts Rate (Rates of Interest) Rules, 1995.

**And the Plaintiff claims:**

1. The sum of \$4,465.00
2. Interest in the sum of CIS calculated at the prescribed rate at 2 3/8 per year from to date.
3. Fixed cost of CIS200.00 alternatively cost to be assessed
