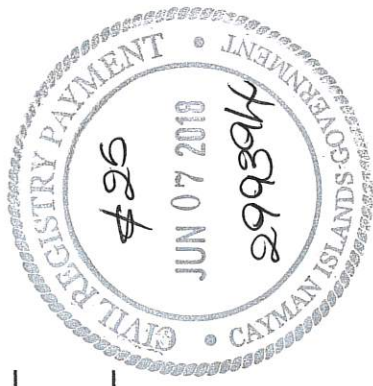

THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after service of this **Plaint** on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495, George Town, Grand Cayman KY1-1106, Cayman Islands, the accompanying Acknowledgment of Service form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out **full particulars of your defense** in the space provided in the Acknowledgement of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defense, the Plaintiff may apply for a **default Judgment** without any further notice to you.

PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

1. In December of 2016 you rear-ended (the Plaintiff) Mr. Ebanks motor car causing him to slam into another vehicle thus causing extensive damage to his motor car.
2. You both agreed that you would pay for all the damages and not get the police involved, you both exchanged numbers and left.
3. The Plaintiff produced two estimates of what it would cost to repair his vehicle, the cheapest invoice was \$8,430.00 you stated that you could not pay all of the monies at one time and you wrote an agreement letter stating that you would pay \$1,000.00 as partial payment. This was signed by you on December 12, 2016.(Exhibit 1)
4. Mr. Ebanks has tried to call you several times after this but you continued to make excuses stating to call a Mr. James Parsons to deal with the situation and when he was called he stated that he could not do anything.
5. The Plaintiff went to a collection agency and paid them \$1,686.00 to try to recover his funds and again you refused to pay.
6. On May 14 2018 you were given a demand letter and you refused to abide by it
7. As such as of Thursday June 7 2018 the defendant owes the plaintiff \$10,116.00 interest at 2.34% of (8430.00) \$279.63

AND the Plaintiff claims:

1. The sum of \$10,116.00
2. Interest of \$279.63
3. Fixed costs of \$175.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
4. Total cost \$10,720.63.
