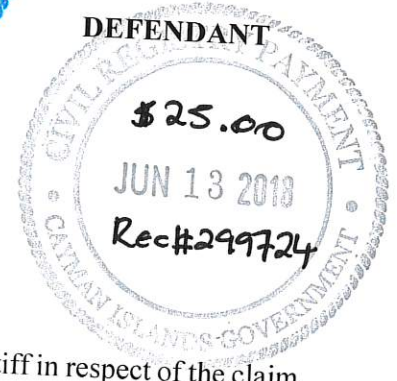

Particulars Of Claim

1. By a verbal agreement on or around the 25th April 2018, the Plaintiff agreed to lend to the Defendant \$1,000.00 (KYD) Cayman Island Dollars on the agreement that the said amount would be re-paid within 3 days, namely by the 27th April 2018.
2. The Claimant paid over to the Defendant in cash KYD\$1000 on the 25th April 2018.
3. The repayment was due on or around 27th April 2018 the but in breach of the agreement the Defendant has failed to pay all or any part of the amount owed.
4. The Plaintiff further claims interest under Section 34 of the Judicature Law 2017 on the sum of \$1000.00 from the 27th April 2018 at the rate of 2.38%.

And the Plaintiff Claims

1. The Sum of \$1000.00
2. Statutory Interest on the sum of \$1000.00 amounting to \$2.99 KYD to the 13th June 2018 and continuing at a daily rate of \$ 0.065.
3. Fixed Cost (Fixed cost on filing \$25, cost of service \$30, Cost \$150) or cost to be assessed in line with summary court rule 11.
