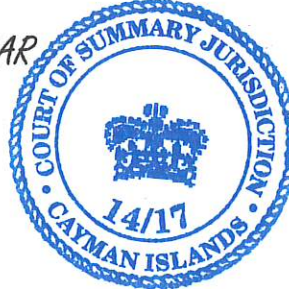

(B) **SaveMore does not recognize collision coverage offered by overseas auto insurance policies or credit cards without verification of coverage.** If your home auto policy covers you for car rentals outside of your country, you may decline our optional collision damage waivers and accept full responsibility for all damages which may occur. You will be required to pay SaveMore up-front for loss or damage to the Car and or third parties in this case. We will provide you with any reasonable aid necessary for re-imbursment from your credit card company or your insurance provider. To protect yourself from undue risk, we strongly recommend that you check with your credit card or insurance provider to verify that you are covered specifically within the Cayman Islands.

(C) **Deposits and Security for Credit Card, Debit Card and Cash Rentals: All deposits MUST be paid in full, and in advance, prior to receiving the Car.** The minimum deposit requirements are as follows: Credit Cards – US\$100 deposit plus rental charges; Debit Cards – US\$305/CI\$250 plus rental charges; Cash Rentals – US\$305/CI\$250 plus rental charges, and subject to age restrictions. The Renter will be subject to certain restrictions and/or higher deductibles/deposits/coverage fees/additional fees under the following conditions: Renter is using cash or a debit card as security; Renter is between the ages of 21 to 24 years old, or has authorized additional drivers between 21 and 24 years old; Renter or authorized drivers have health issues and/or disabilities or driving permit class restrictions/endorsements. Premium, Luxury and Specialty classes are subject to higher deposits, and can only be secured using a major credit card. **Any extensions to the rental period MUST be paid for in advance. SaveMore will only reimburse refunds to a credit/debit card, or by cheque unless otherwise agreed. SaveMore reserves all rights to adjust/waive fees and/or deposits, and ease restrictions at the sole discretion of its management.**

**6) Supplemental Coverage options, Daily Fees, Deductibles and Restrictions – (subject to Paragraph 5)**

(A) **Third-Party Liability Waiver (TLW):** US\$9 daily for Third-Party claims only. A major credit card is required. This option totally covers you for third party damages if you decline the Loss Damage Waivers offered. Should this option be chosen, the Renter accepts full responsibility for any loss of, or damage to the CAR. Sign here if you are accepting ONLY the Third-Party Liability Waiver (TLW) \_\_\_\_\_

(B) **Basic Loss Damage Waiver (BLDW): US\$999 deductible at US\$15.00 daily. Mandatory for rentals secured with cash or debit cards.** Minimum US\$305/CI\$250 deposit required, plus rental paid in advance. Covers loss and damage jointly or separately to the Car and/or third parties.

(C) **Premium Loss Damage Waiver (PLDW):** US\$555 deductible at US\$19.99 daily. Covers loss and damage jointly or separately to the Car, and/or third parties. Major credit card or corporate purchase order required. Available only to drivers aged 25-70 years old.

(D) **Deluxe Loss Damage Waiver (DLDW):** US\$0.00 Deductible. Major credit card or corporate purchase order required. Available only to corporate/government rentals or drivers aged 25-70 years old. Covers for damages or loss to the rental car and third parties. The preceding terms apply for the Car categories which follow at the daily rates specified: i) US\$25 for Economy, Compact and Midsize cars; ii) US\$29.99 for Full-Size cars, SUVs, CUVs, Light trucks and Vans; iii) US\$35.95 for Premium, Luxury, and Specialty vehicles.

(E) **If applicable, Renter declines Loss Damage Waivers offered by SaveMore, and confirms to have verified that the credit card offered as security for this Contract and/or private auto insurance will provide the necessary collision damage coverage for the Car and third parties.** Renter agrees to be fully responsible for any damages to the Car or third party losses, unless such losses are determined by law enforcement or SaveMore's insurance company to not be the Renter's fault. Renter is liable to pay for all charges prior to leaving Grand Cayman, which include but are not limited to: Full market value of the Car including shipping, duty, transport, brokering, and other fees required to import the replacement Car to Grand Cayman; or the total cost of repairs to the Car and/or third parties, plus key/fob replacement/copying and/or programming, towing fees, storage and impound fees, plus administrative charges for claims processing, plus the loss of revenue due to down time, and rental costs for third party replacement Cars.

7) Renter offers credit card/debit card which is recorded, attached/affixed/photocopied/imprinted hereon as security for this Contract and gives SaveMore the right to submit a charge for payment for all charges as needed. A penalty fee of 6.5% will be charged and accrued to any unpaid balance after every 30 days over-due. All charges are subject to final audit and if an error is found, the Renter or SaveMore shall pay or credit the other to correct the error. By signing the contract, you agree to pay all charges at the agreed rates, and any penalties that may arise.


8) **Renter and authorized drivers shall immediately report to The Royal Cayman Islands Police at 345-949-4222 or 911, and to SaveMore any accident or incident in which the CAR is involved.** The Renter or authorized driver shall not admit to any guilt, or liability, but shall cooperate with the Royal Cayman Islands Police, SaveMore, and the Insurer SaxonMG in all matters relating to the investigation of the accident or incident. Renter will promptly pay for all charges arising from the Contract, including but not limited to: rental charges, costs not covered by Loss/Damage Waivers, refueling fees, cleanup, damages caused by negligence or abuse, or other reasonable industry standard charges. Renter shall pay SaveMore all fines and penalties levied by any government department or government owned company or statutory board or agency, and all expenses incurred resulting from the violation of any laws of the Cayman Islands. Should the Renter refuse to pay SaveMore such costs and expenses, SaveMore shall retain an attorney at the Renter's expense in order to collect such costs from Renter, as well as any applicable penalties and interest charges. Please contact us 24 hours in advance if you need to extend your rental period, as the vehicle may be reserved, and additional charges will apply. **SaveMore can and may consider the Car stolen if it is kept beyond the agreed return date.** As a reminder, customers who decline OR are ineligible for the coverage waivers are taking full responsibility for any losses, or damages suffered by SaveMore, and/ or any third parties.

**POLICIES, TERMS AND CONDITIONS FOR RENTING**

1) SaveMore Rent-A-Car Ltd. (hereinafter "SaveMore") is duly licensed to rent vehicles as defined by the Laws of the Cayman Islands. The rental vehicle (hereinafter "Car") is the property of SaveMore, and the person renting (hereinafter "Renter") considers the Car to be in good condition and accepts it as is upon taking receipt, and agrees to all the policies, terms and conditions stated herein. This document, plus any addendums, forms or supplementary documents must be signed by the Renter, and shall be considered the entire Rental Agreement (hereinafter "Contract") between SaveMore and the Renter. **No oral statements or oral amendments whatsoever are valid.** This Contract shall hereby be amended to conform with the Laws of the Cayman Islands, which shall be the sole Court of Jurisdiction.

**2) Renter's Obligations; Restrictions of Use; Violations of Contract**

All drivers are required to have a reasonable knowledge of the Cayman Islands traffic laws, road rules and signs. All drivers are required and expected to have all of the necessary training and experience in the proper operation of a modern automobile, and as such, possess a knowledge of all the controls, with a reasonable familiarity of typical configurations of such controls in a variety of normal cars and trucks in regular production, as well as understanding the instruments and gauges. Renter shall return the Car to SaveMore in the same condition in which it was received, with a full tank of the correct fuel, at the place it was received unless otherwise agreed, and on the agreed date and time, or sooner upon demand by SaveMore. **SaveMore may peacefully repossess the Car at any time without notice at the Renter's expense.** Renter indemnifies and holds SaveMore harmless for loss of any personal possessions left in the Car. The Renter and authorized drivers shall not: leave the Car without removing the keys; use the car to aid, abet or to commit a crime, drive the car on any beach; overload the Car beyond its legal seating capacity; give SaveMore any false or misleading information; operate the Car under the influence of alcohol or substances known to impair driving ability, or while sleepy/fatigued; use the Car for transporting goods, hazardous materials, property, or persons for hire, or in any race, speed test, contest, or to teach driving. Renter shall not operate the Car in any wanton, abusive, negligent, reckless, or unlawful manner, or to push, pull, or tow any boat, car, or trailer, or to transport any object on the top of the Car. Renter shall not deliver any object into the cabin/trunk/cargo area that will buckle, warp, corrode or fatigue the cargo box/bed/lining/trunk, tie-downs/anchors, tailgate, trunk lid/lock, or that will damage tail-lights, seats/seatbelts & seatbelt mechanisms, child-seat restraints/anchors, interior aesthetics, doors/door opening mechanisms/locks, controls, and instruments, rendering such parts unusable or unsafe according to the manufacturer's specifications. Renter and drivers shall operate the Car in a sensible manner; exercise all due care and caution and, as such, Renter's responsibilities shall be, but NOT limited to: securing objects and material so they will not create road hazards; being realistically alert, and aware of what is happening in the Car as well as outside, while adjusting one's driving accordingly in real time, day or night. SaveMore's obligations are void if the Renter violates any of the terms and conditions of this Contract, however, Renter's obligations and SaveMore's rights shall remain. **Renter must report any traffic ticket, citation, or violation to SaveMore within 24 hours and pay them promptly, before leaving the island.**

**3) Driving Ages; Additional Drivers**

**RENTER and drivers must be a minimum of 21 years of age or a maximum of 70 years old. Only drivers listed on the CONTRACT are authorized to drive the Car.** All authorized drivers must present a Full Driver's License, valid for at least 1 year, and have no history of accidents caused by careless driving, or DUI. Drivers aged 21 to 24 years old can be added to the CONTRACT, subject to a YOUNG DRIVER SURCHARGE of US \$10/CI \$8.20 daily, per driver. Not all Car categories or loss/damage waiver options are available to Renters and drivers younger than 25 years old. Additional drivers may be added to the CONTRACT for an additional daily fee per driver; the Renter's spouse is exempt. **SaveMore reserves the right to adjust/waive fees and/or deposits, and ease restrictions at the sole discretion of its management.**

**4) Fees, Taxes, Extra Services, Rental Charges**

(A) Visitor's Driving Permit - US\$20/CI\$16 (one-time fee) per driver. Required by all authorized drivers of the Car who do NOT possess a Cayman Islands Driver's License or International Driving Permit in accordance to Part 3, Section 28, Traffic Law - 2011 revision.


(B) Minimum rental charge: 1 day based on 24 hours. A minimum of US\$10/CI\$8.40 will be charged for every hour past the DUE IN date and time. **NO SMOKING ALLOWED.** If the Car shows evidence of smoking, or is excessively dirty or foul smelling upon return, professional cleaning charges incurred by SaveMore will apply. Fuel costs are not included in the rates. Return with a full tank of fuel or a minimum refueling charge of CI \$7/US \$9 per imperial gallon will apply. Renter will be charged for one day's rental if the Car is returned with wet seats. **Car delivery and collection will incur extra fees.**

(C) If the Renter instructs SaveMore to bill any third party for payment of charges due on this Contract, and if that third party fails to pay promptly, Renter shall pay all such charges immediately on demand by SaveMore, plus monthly interest at 5.5% on the balance after every 30 days past due. An additional charge will be applied for operating outside of SAVEMORE's normal open hours.

**5) Optional Loss Damage Waiver Information (see Paragraph 6 - Supplemental Coverage Options)**

(A) SaveMore **DOES NOT** sell insurance, but offer Loss/Damage Waiver (LDW) options to cover accidents, damages or losses to the Car and/or third parties jointly or separately, providing damages/losses are not caused due to breach of the Terms and Conditions of the CONTRACT, in which case LDW coverage purchased by Renter will be deemed null and void and Renter shall be liable for ALL damages or losses whatsoever. LDW coverage options are offered to legally reduce the total financial liability of the Renter in the case of damages, to the agreed deductible, which must be paid prior to leaving Grand Cayman. **Loss/Damage Waivers DO NOT cover: Air-Conditioning controls; Infotainment systems, displays and speakers; Keys/smart keys/key fobs or programming/activation; Damage caused by using the wrong fuel; Seat-belts/restraints and airbags; Tires damaged beyond economical repair; Spare tire and tire changing tools; Stains, burns and cuts/tears to upholstery or dashboard/steering wheel, or wet upholstery; Professional cleaning/sanitizing; Natural or man-made disasters; Theft/vandalism or attempted theft or vandalism; Damage or loss of any parts, tools, equipment or accessories necessary for the Car to be deemed legally roadworthy due to negligence, abuse, theft/vandalism, or operating the CAR recklessly; Damages caused by unauthorized/unqualified drivers WILL NOT be covered by the Loss/Damage Waivers.**
