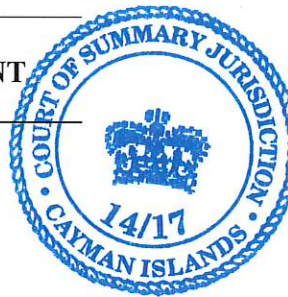

If you fail to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff is a Bank carrying on business at its branch at Elgin Avenue, PO Box 1097, George Town, Grand Cayman KY1-1102 and elsewhere, and the Defendant is and at all material times, has been a customer of the Plaintiff at the said branch.
2. The Defendant is currently indebted to the Plaintiff in respect of his Personal Loan Account #014-21073 in the principal sum of CI\$4,940.16, plus interest which will continue to accrue at the rate of 11.75% per annum until payment. The arrears amounted to CI\$1,515.00 as at 22 May 2018. The Unsecured Loan Account is repayable on demand.
3. The Plaintiff has made written demand for payment of the arrears on the Unsecured Loan Account by letter dated 23 May 2018 and served on the Defendant on the 31 May 2018 from its attorneys but the Defendant has failed to repay all or any of the said sum. The Plaintiff now seeks repayment of the full amount now due under the Personal Loan Account.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the said principal sum of CI\$4,940.16;
2. Interest on the principal sum of 11.75% per annum as contractually agreed.
3. Costs.
