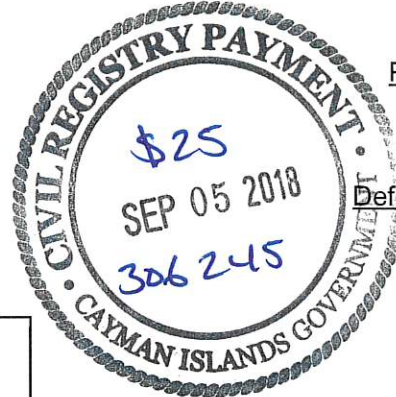

RE: Particulars

Mr. Denny Hydes contacted me in the early part of May 2017 regarding installing tiles at his Newlands residence.

I wanted;

1. I wanted his Mercury 250 outboard engine that was supposed to be in good working condition.
2. I wanted my back porch screened in.
3. I needed my boat gas tank lengthened.

He wanted;

1. He wanted me to tile 583 square feet at his Newlands Residence.

His sister wanted;

1. Sharon wanted a bathroom tiled at her parents West Bay residence tiled.

Things Done;

1. I installed the tiles at Mr. Hydes residence.
2. I installed the tiles at Sharon and Mr. Hydes parents residence in West Bay.

I did not mention anymore as I held my part of our verbal contractual agreement. Mr. Hydes did not! Mr. Hydes was supposed to screen my patio, he did not. His sister paid him \$500 cash for the work I did at their parents residence. I gave Mr. Hyde \$400 cash in his hands as a part payment for the engine. I installed 583 sq. feet of tiles at Mr. Hydes residence and to date have not received payment for that work. The engine that was delivered to my residence is seized and is beyond affordable repairs. Mr. Hydes sold me an engine that was supposed to be in good working condition and it does not.

I hope this is understandable to the courts, if not I would be happy to appear in person to explain it better.
