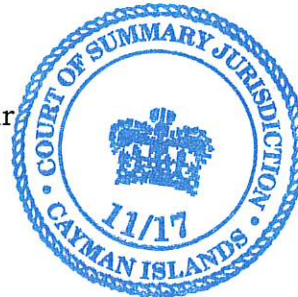

**THIS PLAINT** has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

WITHIN 14 DAYS AFTER SERVICE OF THIS PLAINT on you, counting the day of service, you must either satisfy the claim or return to the Court's Office, P.O.Box 495, Grand Cayman, the accompanying Acknowledgment of Service form stating therein whether you intend to contest this action. If you intend to contest the action in whole or in part, you must set out full particulars of your defence in the space provided in the Acknowledgment of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgment of Service form containing full particulars of your defence, the Plaintiff may apply for a Default judgment without further notice to you.

PARTICULARS OF CLAIM

---

1. The Plaintiff resides at #44 Randyke Gardens, George Town, Grand Cayman.
2. The Defendant is a resident of West Bay, Grand Cayman.
3. In or around June 2017, the plaintiff loaned the sum of CI\$1,000.00 to the defendant who promised to repay the full amount within 30 days of the loan.
4. The defendant paid the plaintiff the sum of CI\$200.00 towards his indebtedness to him but did not make any further payments leaving the balance of CI\$800.00 unpaid.
5. That despite demands made to the defendant by the plaintiff and his attorney for the payment of this balance, the defendant has failed/refused to repay the said balance of CI\$800.00.
6. As a result of the defendant's failure/refusal to make payments, the plaintiff has suffered loss and damage and seeks and is entitled to the relief sought below.

WHEREFORE THE PLAINTIFF CLAIMS FROM THE DEFENDANT:-

- a) Damages in the sum of CI\$800.00
- b) Costs in the amount of CI\$205.00
- c) Pre- and Post Judgment interest from July 2017 to date of full payment at the prescribed rate of 2 3/8% per annum pursuant to the Judicature Law {2007 Revision} and the Judgment Debt Rates of Interest Rules, as amended from time to time.
- d) Such further and/or other relief as the Honourable Court deems appropriate.
