If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

AMENDED STATEMENT OF CLAIM

1. At all material times the Plaintiff was the owner and driver of a Toyota Hiace registration 143226 and the First Defendant was the owner of a Toyota Hiace registration 115930 being driven by their employee, the Second Defendant ~~Vinod Bondi~~ in the course of his employment. The First Defendant is vicariously liable for the negligence of their employees.
2. On the 7 August 2015, the Plaintiff was travelling along North Church Street in a northerly direction towards West Bay and the First Defendant's vehicle was travelling in the opposite direction. The Second Defendant ~~Defendant's employee~~ lost control of the vehicle and swerved into the path of the Plaintiff causing an impact and pushing the Plaintiff's vehicle into the sea wall in the vicinity of the Lobster Pot restaurant.
3. At all material times the Defendant's vehicle was insured with British Caymanian Insurance Company Ltd who had issued a policy of insurance relating to the vehicle in accordance with the Motor Insurance (Third Party Risks Law).

Particulars of negligence

4. The accident was caused by the negligence of the Second Defendant's ~~servant or agent, Vinod Bondi,~~ in the course of his employment with the First Defendant in that he;
 - 4.1 failed to keep any or any proper look out;
 - 4.2 failed to see the Plaintiff in time or at all;
 - 4.3 drove into the Plaintiff's path when it was unsafe and dangerous to do so;
 - 4.4 failed to apply his brakes whether in time or at all;
 - 4.5 failed to steer or control his vehicle so as to avoid the said collision;
 - 4.6 failed to maintain his vehicle within his own lane;
 - 4.7 res ipsa loquitur.
5. By reason of the aforesaid, the Plaintiff has suffered personal injury, loss and damage.

Particulars of General Damage

6. The plaintiff's date of birth is the 21 March 1950 and at the date of the accident he was 65 years old.
7. Due to the intensity of the impact, the steering column pinned his legs in position and the windshield smashed. The plaintiff was knocked unconscious for a short period of time. The Plaintiff was trapped in his vehicle and had to be cut out by the fire brigade. He was immediately aware of significant pain in his knee and chest. He was placed on a spinal board and taken to the Accident and Emergency Department at George Town Hospital by ambulance.
8. He was provided with IV fluids and underwent radiology of the spine, chest and pelvis. He was diagnosed as having suffered an injury to his right leg and knee and an MRI scan was ordered. He was prescribed pain relieving medication.
9. He reattended at the GP and hospital on numerous occasions thereafter with pain to his knee, shoulder, neck and chest.

10. He was treated by Cayman Orthopaedic Group for a torn posterior cruciate ligament and was fitted with a knee brace as it was assessed surgery would be too difficult. This allowed him to walk for short periods of time.
11. In 2004 the Plaintiff underwent an anterior cervical fusion. Following the accident, he suffered from pain in his neck particularly when at work. He underwent epidural injections with Dr Stanley to attempt to alleviate the pain. He has recently undergone C5 nerve block injections performed by Dr Akinwunmi.
12. He suffered double crush syndrome in his left hand and underwent surgical decompression of the median nerve.
13. He suffered a left sided torn rotator cuff and underwent two surgeries to repair the tear.
14. The Plaintiff has recently undergone an operation to repair a meniscal tear in his right knee. The Plaintiff had undergone extensive physiotherapy and continues to undertake the recommended exercises at home.
15. The Plaintiff has been advised he may require further surgery to repair a tear in his hip.
16. The Plaintiff continues to suffer from his injuries and is unable to work.

Particulars of Special Damage


17. The Plaintiff's particulars of special damage will be forwarded in due course by way of a Schedule of Loss including but not limited to claims for cost of medication, loss of earnings, travel and gratuitous care.
18. The Plaintiff is self employed as a taxi driver, he was unable to work immediately after the accident, he was able to return on a restricted basis in April 2016. Since his shoulder operation in June 2017, he has been unable to work at all.

Statement as to Interest

19. The Plaintiff will claim interest pursuant to section 34 of the Judicature Law (2017 Revision) at half the rate as prescribed under the Judgment Debts (Rates of Interest) Rules (as amended) from the 7 August 2015 to Trial.

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.
7. Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
