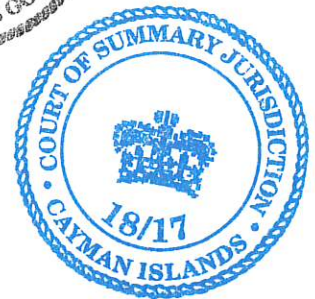

**THIS PLAINT** has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after service of this Complaint on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out full particulars of your defence in the space provided in the Acknowledgment of Service form.

If you fail to satisfy the claim or to return the Acknowledgment of Service form containing full particulars of your defence, the Plaintiff may apply for a default judgment without any further notice to you.

**PARTICULARS OF CLAIM**

---

1. The Plaintiff is and was at all material times an authority organised and carrying on business pursuant to the laws of the Cayman Islands. The Plaintiff's address for service is care of its attorneys, HSM Chambers, P.O. Box 31726, Grand Cayman, KY1-1207, Cayman Islands.
2. The Defendant is a resident of the Cayman Islands with a mailing address of P.O. Box 202, Grand Cayman, KY1-1301, Cayman Islands.
3. The Plaintiff was at all material times engaged in providing ordinary, emergency and preventative medical care and treatment to residents and visitors in need of medical treatment. The Defendant required hospitalization and/or received treatment during the period of 28 August 2015 to 8 September 2015. There was no formal contract drawn between the parties.
4. The Plaintiff provided the Defendant with the following invoices following delivery of medical services (collectively "the Invoices"):

5. The Defendant failed to make full payment of sums due in respect of the Invoices notwithstanding a payment request letter dated 12 February 2018 which was mailed to the Defendant by its attorneys, HSM Chambers, on the same date. Further, on or around 3 October 2018, the Defendant was personally served with a formal demand letter dated 26 September 2018.
6. Accordingly, as of the 31 October 2018 the Defendant owed to the Plaintiff the principal sum of CI\$4,036.47. Further, the Plaintiff claims statutory interest pursuant to Section 34 Judicature Law (2017 Revision) and the Judgment Debts (Rates of Interest) Rules, 2012 from 31 October 2018 and continuing at the daily rate of CI\$0.26 per diem:

7. As a result of the above, the Plaintiff is entitled to the relief claimed in this proceeding.

AND THE PLAINTIFF claims:

- a) CI\$4,036.47 being the principal sum;
- b) Pre and post Judgment interest pursuant to Section 34 *Judicature Law (2017 Revision)* and the Judgment Debts (Rates of Interest) Rules, 2012 at the rate of 2.375% from 31 October 2018 continuing in the sum of CI\$0.26 per diem;
- c) Fixed costs to be assessed pursuant to the Summary Court Rules 2004;
- d) Such further and other relief as this Court may deem just.

## INDORSEMENT

The principal amount claimed in respect of the debt is CI\$4,036.47 as of the date of filing. The amount of the filing fees to commence the proceeding is CI\$25.00 together with a claim for fixed costs of CI\$150 upon commencement of this claim. If, within the time for returning the acknowledgement of service, the defendant pays the plaintiff or its attorneys-at-law the total amount claimed in principal and the costs of issuing the Plaint, further proceedings will be stayed. The money must be paid to the plaintiff or to its attorneys-at-law.

## INDORSEMENT REGARDING INTEREST

1. Interest is claimed pursuant to Section 34 *Judicature Law (2017 Revision)* and the Judgment Debts (Rates of Interest) Rules, 2012.
2. The prescribed rate of interest is 2.375% per annum.
3. The date from which interest is payable is calculated is from 31 October 2018 and continuing in the sum of CI\$0.26 per diem.
