STATEMENT OF CLAIM

1. The Plaintiff is a legal firm situated at Cayman Business Park, 10 Huldah Ave., George Town, Grand Cayman.
2. Between October 2010 and November 2011 the Plaintiff provided legal services to the Defendant related to Immigration matters that the Defendant was engaged in with the Cayman Islands Immigration Department.
3. From time to time, the Plaintiff and the Defendant would discuss payment of the Defendant's legal fees of which he promised to pay.
4. On or about 28 July 2017 the Defendant requested that the Plaintiff render billing to the Defendant for said legal fees owed by him to the Plaintiff.
5. On or about 22 September 2017 the Plaintiff rendered their bill for legal services to the Defendant in the sum of CI\$ 10,350:00. Notwithstanding that the Defendant received the said billing demanding payment; he has not paid the sum of CI\$ 10,350:00 owed to the Plaintiff.
