

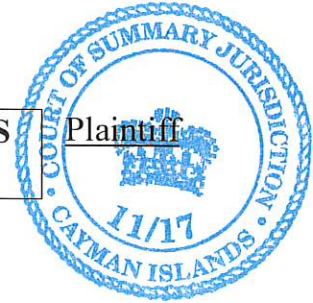

THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out the next page.

Within 14 days after service of this **Plaint** on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the Acknowledgement of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

STATEMENT OF CLAIM

1. The Plaintiff is a legal firm situated at Cayman Business Park, 10 Huldah Ave., George Town, Grand Cayman.
2. Between June 2017 and August 2018 the Plaintiff provided legal representation for the Defendant in the Summary Court on a charge of Driving under the Influence of Alcohol brought against the Defendant by the Office of The Director of Public Prosecution.
3. On or about 9th August 2018 the case against the Defendant concluded with an acquittal of the Defendant by the Court.
4. The Defendant on the 20 June 2018 paid the Plaintiff the sum of CI\$ 700:00 as a retainer and promised to pay the balance of the Plaintiff's legal fees on receipt of the Plaintiff's final billing.
5. On 9 August 2018 the Plaintiff rendered their final billing for the Defendant in the Sum of CI\$ 2,300:00. The Defendant has not paid to the Plaintiff the said Sum of CI\$ 2,300:00 and does not intend to do so unless ordered by this Honourable Court.

1. The Sum of CI\$ 2,300:00;
2. Interest on the said amount as per statute;
3. Cost of CI\$ 350:00;
4. Court Cost CI\$ 25:00;
5. Service Cost CI\$ 60:00.
6. Such further or other relief as the Honourable Court deem fit.
