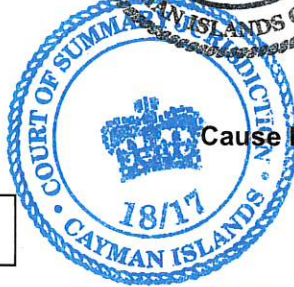

I read the lease agreement which I told them I read it over and over and the lease and doesn't mention when am I going to get back my deposit. After speaking to Mrs. Gordon I realize that she didn't intended to pay me back my deposit Them a few minutes later I received a text message from Mrs. Belinda Gordon I should read the lease again which get me upset because these people taking me for a run.

On the 4 October 2018 I find out that they are home so I call them about my money which Mr. Mark Gordon ask me again to read the lease again, so a few minutes later I receive a message from Mrs. Belinda Gordon out lining how left her television not working, how left bugs in her house, how I destroy her blinds. I tried calling them but they blocked my calls so went to their house.

On Tuesday the 16 of October I went to Mrs. Belinda and Mark Gordon to see if I could settle it out of court but Mr. Mark Gordon refuse to come out to me so I left a message with the tenant Mr. Jamari Gordon to tell them I need my money before the month ends. A few minutes later I received a text from Mrs. Belinda Gordon that I come on her property threatening them and if I come back they would call the police which I wasn't treating them I only went for my money, which I wasn't threatening them ,this really gives an indication that these peoples are not fair .
