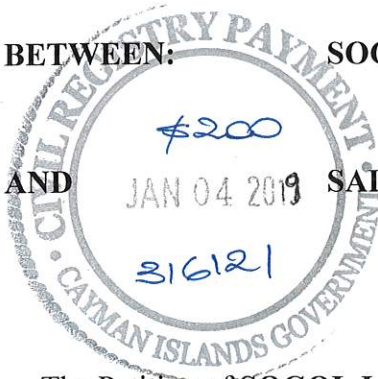

PETITION

The Petition of SOGOL LOHI shows that:

1. That on the 9 June 2017 the above Petitioner was lawfully married to the above Respondent at Toronto, Canada. At the time of the said marriage, the marital status of the parties was as follows:

The Petitioner was divorced  
The Respondent was single

2. That following the celebration of the parties lived together at a rental property located at #75 Lantern Point, Prospect, Grand Cayman, Cayman Islands.
3. That this Court has jurisdiction in the above Cause by reason that the parties have both been domiciled in the Cayman Islands for over one year prior to the presentation of this Petition.
4. That there are no children of the marriage as defined by law.
5. That there is no impediment to this Court granting a decree of dissolution of the said marriage and that there are no legal proceedings continuing either inside or outside of the Cayman Islands in respect of the said marriage to the knowledge of the Petitioner.
6. Since the celebration of the marriage the Respondent has behaved in such a way that the Petitioner cannot reasonably be expected to live with the Respondent. As a result of such unreasonable behaviour, the marriage has irretrievably broken down.

**PARTICULARS OF UNREASONABLE BEHAVIOUR**

- a) That prior to the marriage the parties dated for a period of approximately five years and the parties were happy but were beginning to drift apart. It was believed that if the parties

were to get married, they would get closer and be more committed to the relationship. However, this did not happen.


- b) It was only one month after being married that the Respondent began socializing with friends more than the Petitioner and the Respondent stated to the Petitioner that he no longer had romantic or loving interest for her. The parties stopped being intimate with each other since approximately October 2017.
  - c) The Petitioner could no longer communicate with the Respondent without frequent disagreements and arguments and all issues which would remain unresolved and this led to an uncomfortable environment in the home.
  - d) The relationship became so strained and uncomfortable that the parties moved into separate rooms in May 2018, awaiting the end of the lease agreement. The Respondent moved out of the home into his own accommodation in October 2018 and the Petitioner moved out in November 2018 into her own accommodation.
  - e) Both parties have gone on to live completely separate lives.
7. For the reasons as outlined above, the Petitioner can no longer be expected to live with the Respondent.
8. The Respondent consents to this Petition.
9. There are no assets to be divided between the parties.

**THE PETITIONER THEREFORE PRAYS:**

- 1. That the said marriage be dissolved.
- 2. That each party bears his own costs.
