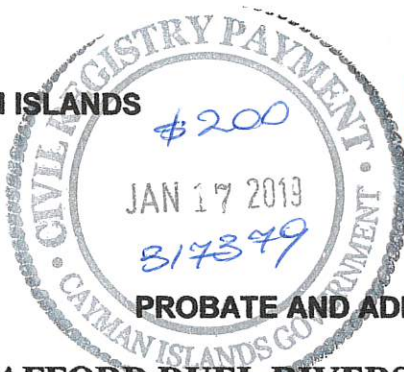

LAST WILL AND TESTAMENT

This is the last will and testament of me, Hafford Duel Rivers of P.O. Box 30656 SMB, 60 Lenders Close, West Bay, Grand Cayman.

I HEREBY REVOKE all former wills and testamentary dispositions by me made and declare this to be my last will and testament.

I HEREBY APPOINT Arden Parsons and Jane Parsons of 96 Bankers Road, West Bay, Grand Cayman and Darcy Kevin Rivers of Billy Manson Road, West Bay to be Trustees and Executors of this my last will and testament.

I HEREBY INSTRUCT my trustees to hold my dwelling house at 60 Lenders Close, West Bay in trust as follows:-

- (a) My wife Phijitra Rivers is to be allowed to continue to reside in my dwelling house in West Bay but if she remarries then she should be allowed to continue to live in my dwelling house for a period of three years but thereafter she must vacate the house.
- (b) My two children Lisha Rivers and William Rivers are to be allowed to occupy my dwelling house with my wife but if she remarries then after three years the house is to be used for the benefit of my two children absolutely in equal shares.
- (c) My lot of land adjoining my dwelling house to the east which does not yet have a separate title is to be subdivided from the land where I have my dwelling house and given to my wife Phijitra absolutely.

My apartments Bl. 1C Pl. 158 located on Boson Bay Road **I LEAVE IN TRUST** and direct my trustees to use the proceeds of any rent therefrom to pay the mortgage, maintain the apartments and provide for my wife and children aforementioned until my youngest child attains the age of eighteen years when the proceeds should be divided equally between my children aforementioned.
