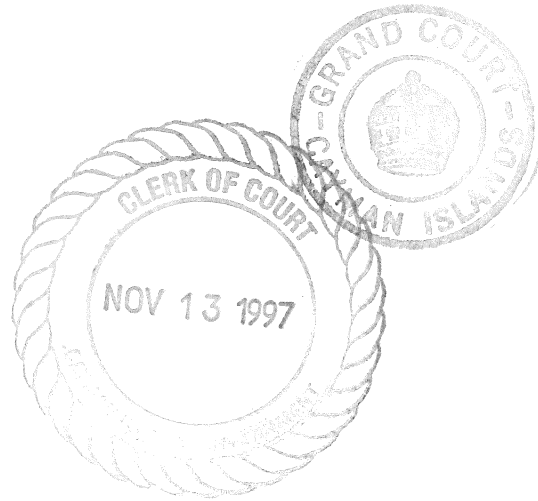
1. That the Petitioner be granted sole custody, care and control of the child of the marriage, TIFFANY CAROL ANN RANKINE born on the 26<sup>th</sup> day of December 1993, with no access to the Respondent.
2. That the Respondent do pay maintenance for the said child in the weekly sum of CI\$50.00, commencing on the 17<sup>th</sup> day of November 1997, with such payments to be made into the Court Funds Office, Government Administration Building (The Glass House), George Town, Grand Cayman or any other place as the Office may be located from time to time.
3. That the maintenance payments as aforesaid shall be made by the Respondent until the said child attain the age of seventeen (17) years or complete her formal education, whichever is the later.
4. That the Respondent do contribute equally to the reasonable educational, medical, dental and optical expenses of the said child of the marriage.
5. That an injunction is hereby granted restraining the Respondent, whether by himself or his servants and/or agents, from assaulting, harassing, molesting, annoying or in any other manner interfering with the Petitioner as she goes about her lawful business.

6. That there be liberty to apply.
7. That there be no Order as to costs.
