

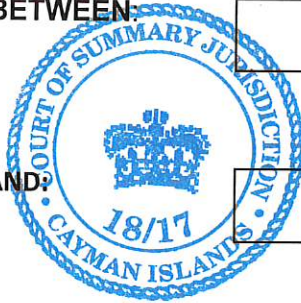

PARTICULARS OF CLAIM

I am filing this Plaint to recover funds paid as a deposit on a rental property I never occupy and my deposit funds was not returned to me. The sum of monies owing is one thousand dollars (CI\$1000.00).

- (1) These funds were paid on in two (2) separate payments on the 19th November, 2018, seven hundred dollars (CI\$700.00), receipt #151607 and on the 1st December, 2018, three hundred dollars (CI\$300.00), receipt #151609. I had planned to move into the apartment on the 1st December, 2018.
- (2) I was given the contract to read and after looking at it and seeing the various restrictions I decided not to rent the apartment and informed the Landlord, Scott Henderson of this and told him that he could go ahead to rent the apartment and return the funds I paid to me.
- (3) The Landlord, Scott Henderson refused to return my money back to me and after several effort to get him to do so he refused.
- (4) I went to the police station and after taking a statement he asked me to go to the Court and report the matter and to file a Plaint for a Small Claim.

And the Plaintiff claims:

- 1) The Sum of \$1,000.00
- 2) Fixed costs of \$150.00 + \$25.00 filing fee alternatively costs to be assessed.
