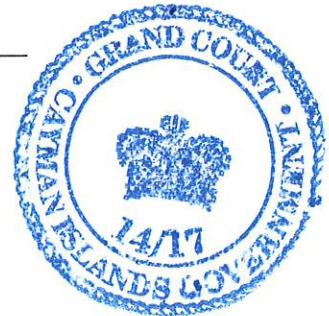

(the "**Securities**").


