who died intestate in East End, Grand Cayman on December 1, 1976





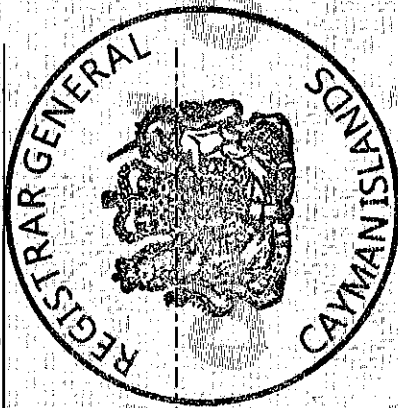
