THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

**WITHIN 14 DAYS** after service of this *Plaint* on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495, George Town, Grand Cayman, the accompanying *Acknowledgment of Service* form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the *Acknowledgment of Service* form.

**IF YOU FAIL** to satisfy the claim or fail to return the *Acknowledgment of Service* form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

### **PARTICULARS OF CLAIM**

1. That at the material time, the Plaintiff was a resident company registered in the Cayman Island and legally practice law.
2. That in or around March 2013, the Defendant entered an agreement with the Plaintiff (" the Agreement").
3. That in accordance with the Agreement, the Defendant agreed to pay the Plaintiff to provide him with legal services.
4. The Plaintiff provide legal service to the Defendant as agreed.
5. The Palintiff provided the Defendant with invoices for the legal services that the Palintiff provided for the Defendant to pay.
6. Between 2013 and September 2015, the Defendand made interim payments towards the invoices.
7. On 17<sup>th</sup> Septemeber 2015, the Defendant made his last payment of CI\$100.00 towards the invoices.
8. The Plaintiff has telephoned the Defendant on several occasion to settle bill but the Defendant ignored the Plaintiff.
9. The Defendant failed to make any further payments.
10. All attempts to resolve this matter has failed and the Plaintiff has incurred financial loss and damages because if the Defendant's failure to pay the sums agreed and within the time agreed.
11. As at 6<sup>th</sup> February 2019, the amount outstanding by the Defendant to the Plaintiff is CI\$2,620.00 plus interests and legal costs.

### **AND THE PLAINTIFF CLAIMS:**

- (a) The sum of CI\$2,620.00;
- (b) Interest on the sum of CI\$2,620.00 at the rate in accordance with the Judicature law from the date of judgment until settlement of same;
- (c) Legal fees and costs;
- (d) Such other relief as this Court deems fit.

If within the time for returning Acknowledgement of Service the Defendant pays to the Plaintiff's Attorneys-at-Law the total amount claimed of CI\$2,620.00 (together with interest and costs) all further proceedings will be stayed.
