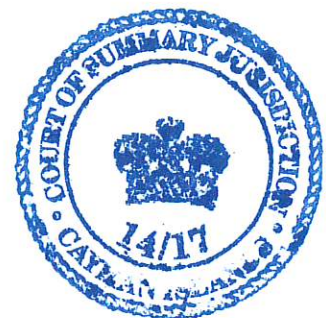
THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

WITHIN 14 DAYS after service of this Plaint on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495, George Town, Grand Cayman, the accompanying *Acknowledgment of Service* form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out full particulars of your defence in the space provided in the *Acknowledgment of Service* form.

IF YOU FAIL to satisfy the claim or fail to return the *Acknowledgment of Service* form containing full particulars of your defence, the Plaintiff may apply for a default judgment without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff is a law firm.
2. The Defendant is a former client of the Plaintiff.
3. By an agreement made in May 2017, the Plaintiff agreed to provide legal services to the Plaintiff and the Defendant agreed to pay for the provision of those legal services and disbursements incurred on her behalf.
4. Pursuant to the agreement, the Plaintiff provided legal services and representation to the Defendant in Grand Court proceedings FAM 242 of 2017.
5. In breach of the agreement, the Defendant has failed to pay for those services and representation.
6. By reason of the said breaches of contract, the Plaintiff has suffered loss and damage.

PARTICULARS OF LOSS

(i) Outstanding fees CI\$6,526

7. In addition to the amount owed as set out above, the Plaintiff hereby claims interest at the judgment debt rate of 2 and three eighths %.

STATEMENT REGARDING INTEREST

- a) The prescribed rate of interest is 2 and 3/8% per annum.
- b) The date from which interest accrues is from the date of issue of this Plaintiff.
- c) The amount of interest accruing each day following the issue of this Plaintiff is CI\$0.43.

AND THE PLAINTIFF CLAIMS:

- (i) The said sum of CI\$6,526.
- (ii) Interest on the said sum of CI\$6,526 per annum from the date hereof to the date of judgment or sooner payment.
- (ii) Costs to be taxed or agreed or alternatively fixed costs in the sum of CI\$150 plus filing fees and bailiff's fee for service.

If within the time for returning Acknowledgement of Service the Defendant pays to the Plaintiff's Attorneys-at-Law the total amount claimed of CI\$6,711 (together with interest and costs of CI\$150 and bailiffs fees of CI\$35) all further proceedings will be stayed.
