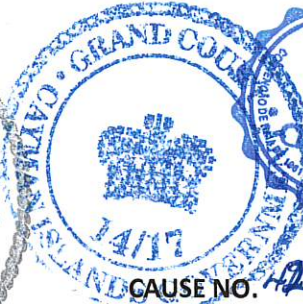
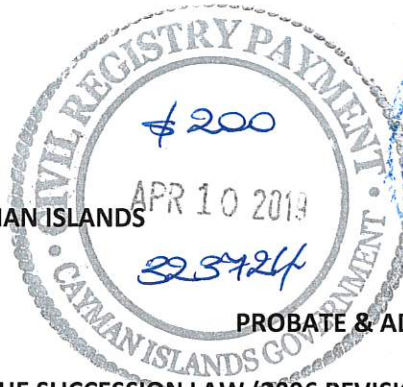

And I annex hereto my affidavit in support of my application along with a certified translation of a copy of the foreign grant of letters of administration and the death certificate.


