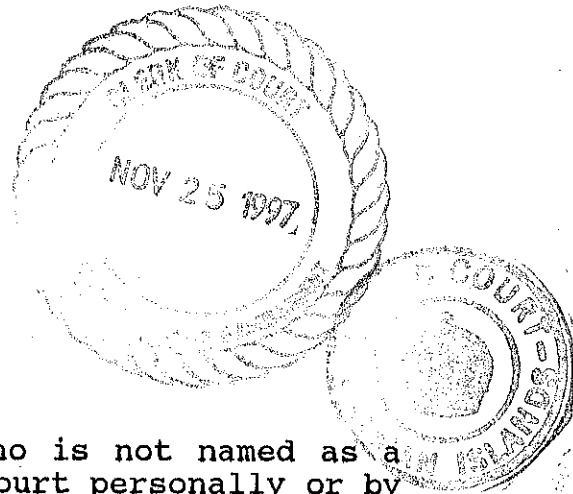
TO: Jack Kennedy Forbes of Breakers, Grand Cayman.

TIME ESTIMATE: The time estimate for this summons is 30 minutes.

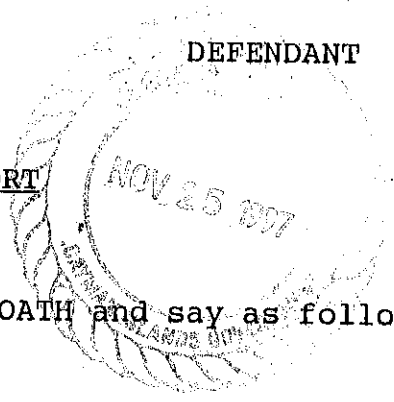

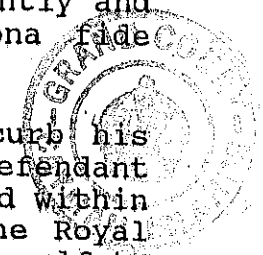

AFFIDAVIT IN SUPPORT



I, Martha Forbes, being duly sworn, MAKE OATH and say as follows:-

1. That I am the Plaintiff herein.
2. That I am the registered owner of the house and land registered in the Land Registry as Registration Section Breakers, Block 56B, Parcel 8 (herein after referred to as the premises).
3. That the Defendant, Jack Kennedy Forbes, who is my brother, is in occupation of the said premises without my licence or consent.
4. That the said Defendant, Jack Kennedy Forbes, has been charged on occasions too numerous to mention for damage to the said premises and to assaulting my sister who lives on the premises with my licence and consent and that he has injured my sister causing her to be hospitalized and take time off work.
5. That on occasions too numerous to mention, the Royal Cayman Islands Police has been called to the said premises to restore order caused by the Defendant using indecent language in the presence of my daughter who is only three years of age and very impressionable.
6. The Defendant uses the premises for consuming illicit drugs. The Defendant is also an alcoholic and drinks constantly and on occasions too numerous to mention disturbs bona fide visitors to the premises.
7. That I have tried to speak to the Defendant to curb his indecent behaviour and his indecent language but the Defendant responds by calling myself and my sister 'whores', and within the two weeks before this Summons was taken out the Royal Cayman Islands Police was called to the premises by myself to investigate the disturbance and the indecent behaviour of the Defendant.
8. On occasions too numerous to mention he has verbally insulted



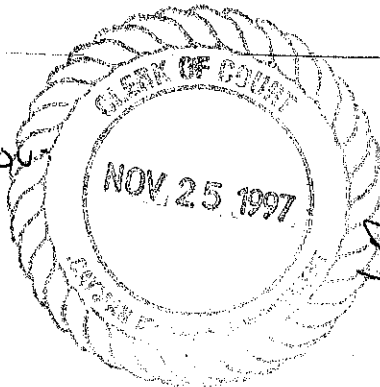
my mother who lives on the premises with my licence and consent, and she is often too afraid to leave her room and constantly lives in fear of him.

9. That the Royal Cayman Islands Police has told me there is very little they can do because everytime that they request the Defendant to leave the premises he will leave for a short while and then return again.
10. The Defendant is of a violent disposition and that he has been convicted in the Court of Grand Cayman numerous times for damage to property and assaulting my mother, my sister and others,
11. That the Defendant sleeps at the premises all day and when he is awake he demands money for drugs and alcohol and he conducts himself in such a way that everyone is afraid of him.
12. That the Defendant is the only person occupied in the premises without my consent and my licence and that in the interest of safety of my daughter, my mother and my sister, I humbly ask this honourable Court to grant me an Order for possession of my premises from Jack Kennedy Forbes who is in occupation without my consent or licence.

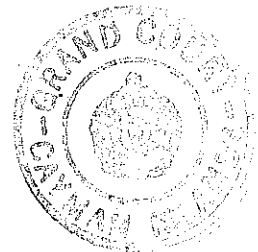
