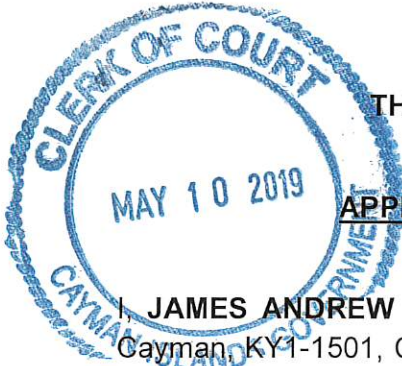

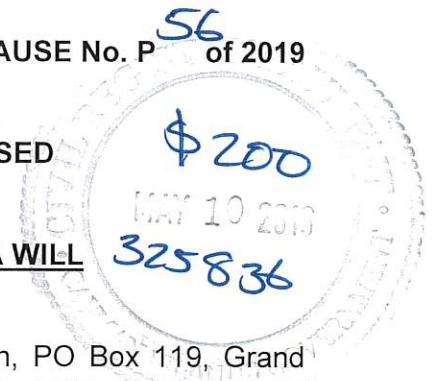

APPLICATION FOR THE GRANT OF PROBATE OF A WILL



I, **JAMES ANDREW EDEN** of 65A Pedro Castle Road, Bodden Town, PO Box 119, Grand Cayman, KY1-1501, Cayman Islands being the Executor named in the last Will and Testament of the late **ARINE LORETTA EDEN**, formerly of 65A Pedro Castle Road, Bodden Town, PO Box 119, Grand Cayman, KY1-1501, Cayman Islands, surviving the deceased, being over the age of 18 years and not having renounced probate, which said Will was made at 113 South Church Street, Grand Cayman, Cayman Islands on the 12<sup>th</sup> day of October 2010 and the said Will, at the time of death of the deceased, having been found at the offices of Ritch & Conolly, Attorneys at Law, George Town, Grand Cayman, Cayman Islands, in the custody of Ritch & Conolly, Attorneys at Law, which said Will, together with the Certificate of Death, is annexed hereto, hereby apply for a Grant of Probate of the said Will to me and I enclose herewith my Affidavit in that behalf and I undertake that in the event of such Grant being made to me, I will:-

- (a) within six months of the grant to me of probate of the said Will, I will prepare a true inventory of the said Estate and exhibit and file the same in the Probate Registry; and
- (b) within one year of such Grant to me, I will administer the said Estate according to the tenor of the Will and the directions, if any, of the Courts and file in the Probate Registry a general account accounting for the whole of the assets of the said Estate.

LAST WILL AND TESTAMENT

I, **ARINE LORETTA EDEN** of P.O. Box 119, Grand Cayman KY1-1501 being of sound mind, do **HEREBY REVOKE** all former wills codicils and other testamentary dispositions heretofore made by me, and **DECLARE** this to be my Last Will and Testament.

1. I appoint my husband, **JAMES ANDREW EDEN** of P. O. Box 119, Grand Cayman KY1-1501 ("my Trustee") to be the Executor and Trustee of this my Will and in case he shall be unwilling to accept the office of Executor or if his appointment does not for any reason whatsoever take effect then I appoint my son, **LINBERN ANDREW EDEN** of P.O. Box 119, Grand Cayman KY1-1501 ("my Trustee") to be the Executor and Trustee of this my Will and I declare that the expression "my Trustee" shall mean and include the person who proves this my Will whether original or substituted by acts of law or otherwise.
2. I give all my real and personal property whatsoever and wheresoever to my husband, **JAMES ANDREW EDEN** (out of which shall be paid my funeral and testamentary expenses and my debts) if he shall survive me for a period of 28 days.
3. If my husband, **JAMES ANDREW EDEN** shall predecease me or shall not survive me for the period of 28 days or if for any other reason the gift to him fails then the following provisions of my Will shall take effect:
  - 3.1 I give all my real and personal property whatsoever and wheresoever (out of which shall be paid my funeral and testamentary expenses and my debts) (and any property over which I have at my death any general power of appointment) to my Trustee on trust for sale with power to postpone sale without liability for loss (and such estate and the property which currently represents it is referred to in this will as "my Residuary Estate").
  - 3.2 My Trustee shall hold my Residuary Estate upon trust for my son, **LINBERN ANDREW EDEN** absolutely **PROVIDED** that he survives me by 28 days.
  - 3.3 If the gift in clause 3.2 above fails for any reason then to hold upon trust for my two grandchildren **JAELEN RAYNE MARLEY EDEN** and **JAYZIN WILLIAM WAILER EDEN** in equal shares upon attaining the age of 18 years.
4. My Trustee shall have the following powers in addition to the powers given to him by general law:

- 4.1 to invest money and to vary and to transpose investments from time to time with the same full and unrestricted freedom to choose investments as if he was a sole absolute beneficial owner;
- 4.2 to apply money in the purchase or improvement of land as a residence for all or any of the beneficiaries for the time being of any trust hereof on such terms as he may in his absolute discretion from time to time impose;
- 4.3 to carry on any business or trade in any part of the world alone or in partnership;
- 4.4 to insure against loss or damage howsoever arising any property for the time being comprised in my Residuary Estate to any amount and to pay any premiums from any such insurance at his absolute discretion out of the income or capital of my Residuary Estate and to use any money received under any such insurance at his discretion either towards making good the loss or damage in respect of which it was received or as if it were proceeds of sale of the insured property;
- 4.5 to advance any capital money from my Residuary Estate in such manner as he in his absolute discretion thinks fit to or for the benefit of any of the beneficiaries for the time being hereof provided that the money so advanced to or for the benefit of any beneficiary shall not exceed in amount the presumptive or vested share in my Residuary Estate of that beneficiary;
- 4.6 to treat as income all the income from my Residuary Estate whatever the period in respect of which it accrues and to disregard in this respect the equitable rules of apportionment;
- 4.7 in any case where my Trustee has power to apply income or capital to or for the benefit of any person who is a minor to accept the receipt of the parent or guardian of such a person or of the minor personally if of the age of 16 years in full discharge and my Trustee shall not be required to see the application of any income or capital so paid;
- 4.8 Section 32(1) of the Trusts Law (2009 Revision) will have effect as regards the income arising from my Residuary Estate as if:
  - (a) the words in subsection (1)(a) "as may, in all the circumstances, be reasonable" were deleted and in their place the words "as my Trustee shall in his absolute discretion think fit" were substituted;

(b) the words from "Provided that" to the end of subsection (1) were deleted.



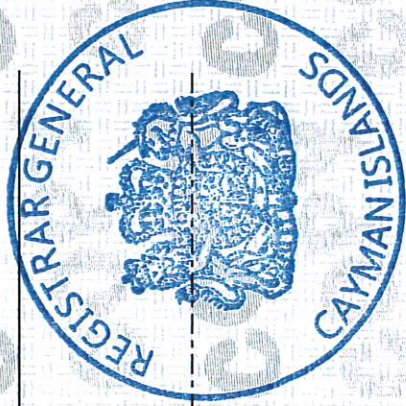
