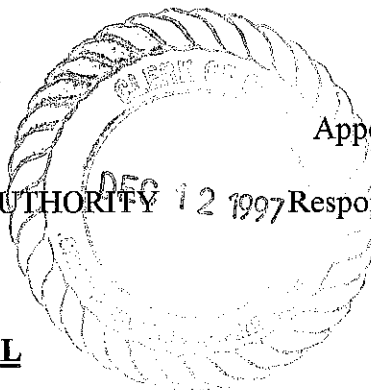

NOTICE OF APPEAL


