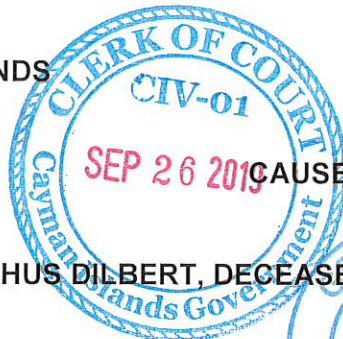

- (a) within six months of the grant to me of probate of the said Will, I will prepare a true inventory of the said Estate and exhibit and file the same in the Probate Registry; and
- (b) within one year of such Grant to me, I will administer the said Estate according to the tenor of the Will and the directions, if any, of the Courts and file in the Probate Registry a general account accounting for the whole of the assets of the said Estate.

1. Earlier Wills and Status

1.1 I cancel my earlier Wills

1.2 I DECLARE that I am domiciled in Cayman Brac, Cayman Islands.

2. Appointment of Executor and Gift of Estate

2.1 **Appointment and Gift:** If my wife **YVETTE LENORCHIA DILBERT** ("Yvette") survives me by fourteen days I give the whole of my estate to her and appoint her my executor.

2.2 **Alternative Provision:** If my wife does not survive me by fourteen days then the following provisions of this Will shall apply.

3. Executors and Trustees

I appoint my children **BRIAN NEIL DILBERT** ("Brian") and **NATALIE PATRICE CHRISTIAN** ("Natalie") as my executor and trustee ("my Trustees").

4. Specific Gifts

4.1 I give:

(a) To Brian any interest I hold in the property at 411 Bight Road, Cayman Brac Registration Section Cayman Brac East, Block 106E Parcel 134;

(b) To my children, Brian, Natalie, Rachel Anneliese Dilbert ("Rachel"), and granddaughter, Alena Grace Dilbert ("Alena") I give equal shares in my property at 409 Bight Road, Cayman Brac, Registration Section Cayman Brac East, Block 106E Parcel 133;

5. Estate

My Trustees shall hold the residue of my estate on trust either to retain or sell it and:



- (a) To pay my debts and funeral and related expenses, my Trustees administration and executorship expenses and any duty payable on my estate; and
- (b) To divide the residue equally amongst my children Brian, Natalie, Rachel, and granddaughter, Alena. Provided that if any of my children dies before me or before attaining a vested interest leaving children, those children (being my grandchildren) shall on reaching 25 years receive equally between them the share which my deceased child (their parent) would have otherwise received.

6. Trustees Additional Powers

My Trustee shall have the following powers (in addition to any statutory powers):

- (a) To sell all or any part of my estate in the manner and on the terms my Trustees may choose;
- (b) To invest and change investments as freely as if my Trustees were beneficially entitled;
- (c) To lend money whether secured or unsecured to any beneficiary (whether contingent or otherwise) free of interest or at such rates of interest as my Trustees may think fit and otherwise on such terms as to repayment and in general as my Trustees may think fit;
- (d) To borrow money on such terms as my Trustees may think fit and use it for any purpose for which the capital of the estate may be used;
- (e) To transfer to any beneficiary in full or partial satisfaction of that beneficiary's share of my estate any asset of my estate not specifically given under this Will, at a value determined by a valuer appointed by my Trustees and (if necessary) without that beneficiary's consent.
- (f) To apply for the benefit of any beneficiary as my Trustees may think fit the whole or any part of the income and capital of the share in my estate to which that beneficiary is entitled or may in the future be entitled; and where the beneficiary is a minor, my Trustees may pay or apply that income and capital to the beneficiary's guardian whose receipt will be a valid discharge to my Trustees.



7. Trustees Not Liable

My Trustees shall not be liable for any loss which may occur to my estate in the carrying out of the trusts of this Will and shall be indemnified out of my estate for any such loss.

8. Ability to Substitute a Trust

Notwithstanding any other provision of this Will, my Trustees may at their absolute discretion pay or apply in whole or in part any benefit which would otherwise go to a beneficiary under this Will to the trustees of any Trust (whether created before or after the date of my death) **PROVIDED THAT** my Trustees shall not make any such payment or application without the written consent of such beneficiary.


9. Burial Direction


