THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

WITHIN 14 DAYS after service of this Complaint on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495, George Town, Grand Cayman, the accompanying *Acknowledgment of Service* form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the *Acknowledgment of Service* form.

IF YOU FAIL to satisfy the claim or fail to return the *Acknowledgment of Service* form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff is and was at all material times a Local Ordinary Resident Company, licenses to carry on business within the Cayman Islands pursuant to the laws of the Cayman Islands.
2. The Plaintiff is a law firm.
3. On 6th April 2018, the defendant entered into an Attorney-Client Fee Contract with the Plaintiff whereby the Plaintiff would provide legal services to the defendant and the defendant agreed to pay for the services (the "Agreement").
4. The Plaintiff provided legal services to the defendant and the defendant have not paid for the services as they agreed.
5. A Demand Letter was served on the defendant by way of personal service on 15 July 2019.
6. As at 6th January 2020, the Defendant owed the Plaintiff CI\$2,200.00.
7. The Plaintiff made several telephone calls to the defendant but each time the defendant would promise to pay but relinquished on his promise.
8. The defendant has failed to make any payments towards the debt.
9. As the defendant has not acted in good faith, has not adhered to the Agreement and has refused to pay the Plaintiff the amount owed.
10. All attempts by the Plaintiff to resolve this matter have been unsuccessful.
11. As at 6th January 2020, the defendant owe the Plaintiff CI\$2,200.00.

AND THE PLAINTIFF CLAIMS:

- (a) The sum of CI\$2,200.00;
- (b) Interest on the sum of CI\$2,200.00 at the rate of 1.5% monthly in accordance with paragraph 6 of the Agreement;
- (c) Costs; and
- (d) Such other relief as this Court deems fit.

If within the time for returning Acknowledgement of Service the Defendant pays to the Plaintiff the total amount claimed of CI\$2,200.00 (together with interest and costs) all further proceedings will be stayed.
