
APPLICATION FOR A GRANT OF PROBATE OF A WILL

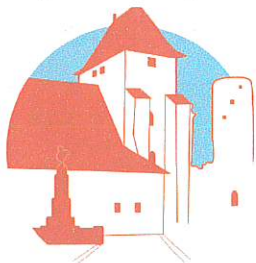

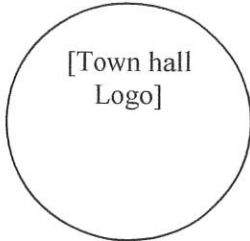
