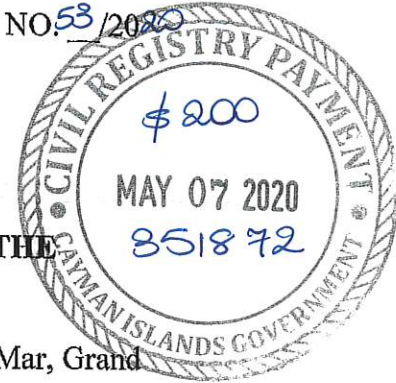


Dated the 28 day of April 2020, and sealed with my seal.

Norwegian Will and do make or cause to be made a just account and distribution account thereof whenever lawfully so required, then this obligation shall be void and of no effect, but shall otherwise remain in full force and effect.




BOND OF SURETY
