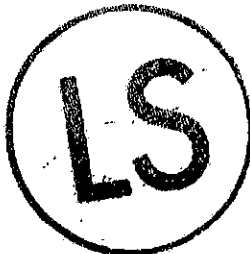



6. ALL other RESIDUAL possessions, properties real and personal I DEVISE and BEQUEATH to LINDSAY JEFFERY.


