PARTICULARS OF CLAIM

1. The Defendant currently rents office space from the Plaintiff at the Plaintiff's property situated at Cardinal Plaza, 30 Cardinal Avenue, George Town, Grand Cayman, Block OPY Parcel 157 under a Lease Agreement dated 1st March 2020 for a term commencing on 1st March 2020 and terminating on 28th February 2021 (hereafter the "Lease").
2. The total monthly payments due under the Lease are CI\$7,200 per annum. The Lease allocated those funds to the following:
 - a. Rent of CI\$3,600 per annum.
 - b. Maintenance contributions (CAM) of CI\$1,350 per annum.
 - c. Utility costs of CI\$2,250 per annum.
1. On signing of the Lease, the Defendant paid a security deposit of CI\$1,200 some of which had been paid under previous leases between the parties, the first such lease of which commenced 1st March 2017.
3. The Defendant operates a secretarial company from the premises, offering various administrative services under the business name "Easy Way Secretarial Solutions".
4. Copies of relevant Lease agreements, amendments, notices, invoices and correspondence are attached.
5. The Plaintiff claims for non-payment of rental, maintenance and utility charges totalling CI\$2,916.93 as at the date of filing, as shown below:
