## PARTICULARS OF CLAIM

1. For the month May 2020 the Defendants failed to pay their rental of CI\$1800, which is normally due the First of every month.
2. The Defendants are aware of a daily late fee of CI\$25 until rent is paid.
3. The Defendants also failed to pay their Water Authority utilities and the outstanding amount is CI\$1130.25.
- 4a. The Defendants has breached their contract Claws: - No pets are allowed in the residence. Also failed to inform landlord of any damage caused to furniture and or fixture that require repairs.
- 4b. At the residence of 90 John Carter Dr, Midland acres a final inspection was carried out on the ending date of contract agreement.
- 4b1. There was fur (Rabbit) found all over the interior of the house. Therefore, the residence had to be deep cleaned at the cost of CI\$250.
- 4b2. One Bed frame (Platform) & Mattress was damage (Full size frame Tomlinson Furniture – SERTA bases W/Legs CI\$170, Cottage Style Headboard CI\$199 & Full-size Mattress CI\$450).
- 4b3. Two missing window screens (Hydes & Sons charge CI\$15 ea).
- 4b4. Hallway full bath shower head broken (Al Thompson CI\$27).
- 4b5. Master Bedroom window damage (Can not use the locks to open it nor Can it stay up) (Al Thompson window Price CI\$250 plus another CI\$250 for removal & installation of window and trim - Triple J Construction).
- 4b6. Bar Stool damaged (The cost for One was CI\$150).
- 4b7. Toilets for the Master & Hallway Full bathrooms (Al Thompson - Complete Flush Valve Kit @\$26 ea).
- 4b8. Laundry Sink Pipe fixings (Al Thompson CI\$8.60).


1. The Sum of CI\$1800 (Rental)
