PARTICULARS OF CLAIM

1. Sometime in December, 2019 I loan my car to my brother Robert Watson.
2. My car was parked when someone unknown to him, Andrade Romario Davis, mistakenly took my brother, Robert Watson for someone else.

4. I paid CI\$3,200.00 of my own money to have the car repaired.
5. The matter was taken to court against Andrade Davis and on the 1st July, 2020 he was found guilty and sentenced to a charge of CI\$1,200.00
6. There is the balance of CI\$2,000.00 to be paid by Andrade Romario Davis to recover the full sum paid for the repairs to my car.
7. I am therefore suing him to recover the said balance amount of CI\$2,000.00.

- 2 Fixed costs of \$150.00 + \$25.00 filing fee alternatively costs to be assessed.
