PARTICULARS OF CLAIM

- On the 1st day of October 2019, the Plaintiff rented a unit at 43 Whitman Seymour Road Unit #82 for CI\$850.00 per month. The rent is due each month on the first day of each month. A security deposit of CI\$950.00.00 was requested and paid in full.
- On July 31<sup>st</sup>, 2020, the Defendant failed to pay the rent, despite the Plaintiff's numerous contacts and request for the outstanding amount, the Defendant continued occupying the unit without paying the rent and left the apartment on July 31<sup>st</sup> 2020.
- As of July 31<sup>st</sup> 2020, the Defendant owes the Plaintiff CI\$ 1,800.00 for outstanding rent. (\$2,750.00 less the security deposit of \$950.00 = \$1,800.00)
- The Defendant should also pay interest at the prescribed rate on the Summary Court Rules.

AND the Plaintiff claims:

- 1- The sum of CI\$1,800 for rent from July 31<sup>st</sup>, 2020 date of breach until 25<sup>th</sup> of September 2020 today.
- 2- Interest in the sum of CI\$ .12 calculated at the prescribed rate per diem until the matter is settled.
- 3- Costs to be assessed
