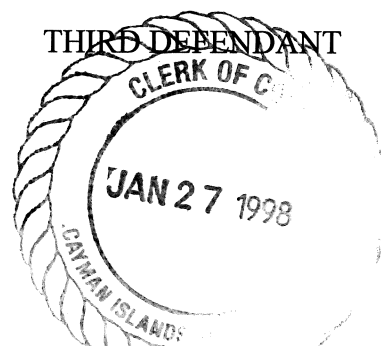

**THIS WRIT OF SUMMONS** has been issued against you by the abovenamed Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P. O. Box 495, George Town, Grand Cayman, the accompanying Acknowledgment of Service form stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment of Service form within the time stated, or if you return the Acknowledgment of Service form without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

**INDORSEMENT**

The plaintiff's claim against the defendants is for damages for personal injuries and consequential loss and damage suffered by the plaintiff caused by the negligent driving on the 28th day of January 1995 of a Chevrolet Impala motor vehicle registration no. 52 449 by the first defendant as servant or agent of the second named defendant and/or third named defendant in the vicinity of Ocean Club, Spotts, Grand Cayman.

**AND** the Plaintiff claims:-

- (a) Damages.
- (b) Pre-judgment interest in accordance with S.34 of the Judicature Law (1995 Revision).
- (c) Post-judgment interest in accordance with S.34 of the Judicature Law (1995 Revision).
- (d) Further and/or other relief.
- (e) Costs.

**STATEMENT REGARDING INTEREST**

The Plaintiff claims interest from the 28th January 1995 to the 31st January 1996 at the rate of 8¾ percent per annum and thereafter to the date hereof at the rate of 7¾ percent per annum and hereafter at the said rate of 7¾ percent per annum or as may be varied from time to time by the Grand Court Rules.
