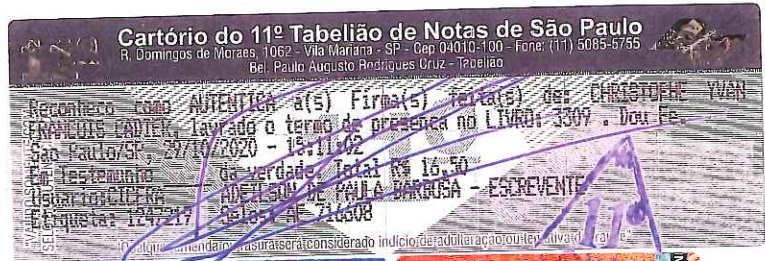

THIS IS THE LAST WILL of me **ALOYSIO DE ANDRADE FARIA** of Alameda Santos, 466 CEP 01418-000, Sao Paulo, S.P., Brazil ("**my Will**") made in relation to all my property in the Cayman Islands ("**my Cayman Estate**").

1. REVOCATION

1.1 I revoke all my previous wills and testamentary dispositions but only so far as they relate to my Cayman Estate.

2. STATEMENT OF DOMICILE

2.1 I declare that I am domiciled in Brazil.

3. EXECUTORS AND TRUSTEES

3.1 I appoint **CHRISTOPHE YVAN FRANCOIS CADIER** of Av. Brigadeiro Faria Lima, 3144 - 3º andar - São Paulo, S.P., Brazil to be my sole executor and trustee.

3.2 In my Will the expression "**my Trustee**" means (as the context requires) my executor and trustee for the time being of any trust arising under my Will.

4. RESIDUARY ESTATE

4.1 I give all my Cayman Estate not otherwise disposed of by my Will or any codicil to it to my Trustee to hold on the terms set out in this clause.

4.2 My Trustee shall:

- (a) pay all my debts, funeral and testamentary expenses, legacies and any tax attributable to my Cayman estate; and
- (b) hold the remainder ("**my Residuary Estate**") on trust on the following terms.

4.3 My Trustee shall divide my Residuary Estate into five equal parts (each a "**Part**") and shall pay or transfer:

- (a) one Part to the trustee(s) for the time being of The FC Family Trust (the "**FC Trust**"), a trust established by a trust deed dated 16 July 2018, as amended, made between me as settlor, The White Dahlia Company Inc. as original trustee and my daughter **CLÁUDIA DE FARIA CARVALHO** as Primary Beneficiary, to be held on the terms of the US Trust as an addition to the trust fund thereof for all purposes;
- (b) one Part to my daughter **ELIANA DE CAMPOS FARIA** for her absolute use and benefit;
- (c) one Part to my daughter **FLAVIA FARIA DE VASCONCELLOS** for her absolute use and benefit;
- (d) one Part to my daughter **JUNIA DE CAMPOS FARIA ZIEGELMEYER** for her absolute use and benefit; and
- (e) one Part to my daughter **LUCIA DE CAMPOS FARIA** for her absolute use and benefit.

4.4 If any daughter of mine named in paragraphs 4.3 (b) to (e) above dies before me then her issue shall take equally the Part which my deceased daughter would otherwise have taken under

clause 4.3 above but provided that no one shall benefit under this provision if his or her parent or ancestor is alive and eligible to benefit.

- 4.5 If the gift of any Part under clause 4.3 above (read in conjunction with the substitutionary provisions set out in clause 4.4 above) fails for any reason, that Part shall be added equally to the other Parts the gifts of which have not then failed.

5. TRUSTEE'S POWERS

- 5.1 My Trustee shall have the powers and protections under the general law, as well as those set forth herein.

6. EXCLUSION OF COMMUNITY PROPERTY

- 6.1 No benefit accruing to any person under my Will shall form or constitute a portion of any communal or joint estate of such person but shall remain their sole and exclusive property. Any such benefit shall be free from any interference, control or marital power of any spouse of that person.

7. INTERPRETATION

- 7.1 The clause headings are included for reference only and do not affect the interpretation of my Will.
- 7.2 The singular shall include the plural and the masculine gender shall include the feminine and neuter genders and vice versa.
- 7.3 Words importing persons shall include firms, corporations and charities.
- 7.4 References to any statutory provision shall include any statutory modification or re-enactment thereof.

8. GOVERNING LAW

- 8.1 My Will and any codicil to it shall be governed by and construed in accordance with the law of the Cayman Islands.

9. TRUSTEE REMUNERATION

- 9.1 My Trustee, as a lawyer, may charge and be paid all usual professional and other charges for any business transacted or work done by him or his firm in connection with the administration and distribution of my estate or of the trusts of my Will whether or not of a professional nature and whether or not any other person could have done the same personally.

10. TRUSTEE'S LIABILITY

- 10.1 My Trustee shall not be liable for any loss or damage to the capital or income of my estate or of any property subject to any trust arising under my Will however arising, unless that loss was caused by his own actual fraud or wilful default.
- 10.2 My Trustee shall not be liable for acting in accordance with the advice of qualified professional advisers unless when he does so:

- (a) he knows or has reasonable cause to suspect that the advice was given in ignorance of material facts; or

(b) proceedings are pending to obtain the decision of the court on the matter.

10.3 My Trustee shall not be responsible for the default of a person to whom his powers are delegated (even if the delegation of this power was not strictly necessary or expedient) provided that he took reasonable care in his selection and supervision.


11. ANCILLARY POWERS


11.1 My Trustee may do anything which is incidental or conducive to the exercise of his functions.
