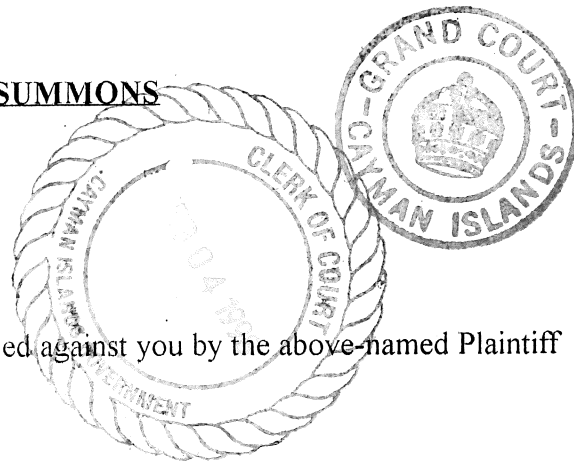

**Within** fourteen (14) days after service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O.Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

**NOTE** - This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by order of the Court.

1. The plaintiff is a Local Company licenced to sell ready mixed concrete.
2. The defendant is a builder.
3. On the 20th January, 1995 the defendant obtained 17 yards of ready mixed concrete along with the use of a Schwing Pump on a job in Northward at a price of \$2,502.25 which the defendant promised to pay but has failed to pay.

Wherefore the plaintiff claims:-

The amount of \$2,502.25 plus interest at the rate of 7 3/8 % p.a. from the 20th January, 1995 until payment with costs to be taxed or agreed.
