And I annex hereto my affidavit in support of my application and the certificate of death of the late Gonzalo McLaughlin.



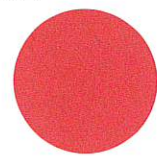

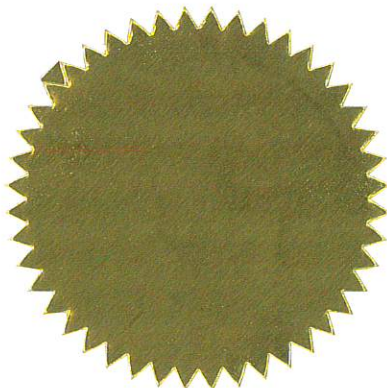
