- 2) within one year of such grant to us, we will administer the said estate according to the tenor of the Will and directions, if any, of the Court and file in the Probate Registry a general accounting for the whole of the assets of the said estate.

**THIS IS THE LAST WILL AND TESTAMENT** of me, **Robert Michael Hamaty**, of the Town of George Town, Grand Cayman, Cayman Islands, British West Indies.

1. **REVOCAATION**

I **HEREBY REVOKE** all former Wills and Codicils by me at any time heretofore made.

2. **TRUSTEES**

I **APPOINT**, my Wife, **Carlene Hamaty**, my Brother **Frederick Clive Hamaty**, my nephew Neil Hamaty, my Daughter **Monique Celia Hamaty-Simmonds** and my Son **Basil Hamaty** to be the Executors and Trustees of this my Will. I **DECLARE** that in the interpretation of this my Will, the expression "my Trustees" and all references thereto shall (where the context permits) mean and include the Trustees who may be acting as such from time to time, whether original or substituted and whether one or more.

3. **FUNERAL AND REMAINS.**

**MY EXECUTORS** shall arrange my funeral. I desire a funeral service to be held in the Cayman Islands and my body to be flown to Miami for cremation and the urn returned to Cayman for placement in a memorial on the grounds of the Tortuga Rum Company Headquarters at Industrial Park with a suitable marble plaque to be installed, identifying me as the founder

of the company. I further desire a memorial service to be held for me at the Saint Josephs Roman Catholic Church on Lewis Street in the Town of Savanna-La-Mar in the Parish of Westmoreland.

4. **TRANSFER TO MY TRUSTEES**

I GIVE all my estate, both real and personal, of whatever kind and wheresoever situate and also any real or personal property over which I may have a general power of appointment unto my Trustees to hold the same upon the following trusts:

(a) Debts and Death Taxes

To pay out of the capital of my estate all my just debts, funeral and testamentary expenses imposed by or pursuant to the Laws of the Cayman Islands that may be payable by my Trustees or by any beneficiary of this my Will or any Codicil hereto in connection with any property passing (or deemed by any such governing law to pass) on my death, or in connection with any insurance, annuities, pension plans, superannuation funds or other similar benefits on my life, or in connection with any gift or benefit given by me either in my lifetime or by survivorship or by this my Will and any Codicil hereto.

For the purposes of paying my just debts and expenses and for the purposes of paying the cash bequests to Rose Maxwell, Delrose Williams, Lisanne Gough, Brian Hamaty, Sonia Thorn and Helen

Furry I have made my estate the beneficiary of three life insurance policies, namely a ManuLife policy numbered 385 2850-1, now Sagicor Life Policy 000385269 in the sum of US\$100,000, and two policies with Sagicor Life of the Cayman Islands Ltd, namely Policy number 8,072,234-1, now Policy Number 000386824 in the sum of US\$500,000 and Policy Number 3,852,994-1, now Policy Number 000385342, in the sum of US\$200,000. I further instruct my Trustees to pay any balance remaining after the payment of my just debts and expenses and the foregoing specific cash bequests to my Wife Carlene, my Son Basil and my Daughter Monique in equal shares.

(b) Specific Bequests

I make the following specific bequests:

To my son Basil

1) My gold watch, chain, radio, shot gun and all other items of personal jewelry that I may die possessed of.

2) My personal cars, my boats named "Tortuga Rum Runner" with trailer, engines and all fishing gear;

To my daughter Monique

My diamond ring

My gold chain and Spanish Coin (gold) and St. Christopher medal

My one half (1/2) share of land at Little Cayman (Block 78A Parcel 34) with Lighthouse held jointly with my sister Sonia

My property on Marina Drive, Spotts, Block 24E Parcels 22 and 247

My share of the property known as Little Cayman Block 78A Parcel 44

To my grandson Brandon Simmonds

My antique pocket watch (gold; by J.W. Benson)

To Rose Maxwell

The sum of 5000 United States Dollars to be paid within 12 months of my death, and is made out of the love and affection I bear towards her, and the years of service she has given to Carlene's mother and the family

To my Daughter Monique and my Son Basil:

- i) My ten percent (10%) share in the restaurant known as "Café Mediterraneo" in the Cayman Islands to be divided equally between them
- ii) My sixty percent (60%) interest in the shares of Tortuga Rum Company Limited, a registered Cayman Islands Company to be divided equally between them

- iii) My one half share of the land at Midland East Block 59A Parcels 81 and 82 held as tenants-in-common with my brother-in-law Jack Furry situate in Frank Sound in the Cayman Islands as joint tenants
- iv) My property and building in West Bay, next door to the Turtle Farm (Block1C Parcel 1) as joint tenants
- v) My property purchased from Reginal Parsons on the waterfront in George Town Grand Cayman known as the Chocolate Box as Joint tenants
- vi) My property located at 1214 Redgate Road Block 20B Parcel 321 H2 and H3 as Joint tenants
- vii) My property located at Little Cayman Block 78A Parcel 38 as Joint Tenants
- viii) My property located at Sunrise Landing, Savannah Block 27C Parcel 702 as Joint Tenants
- ix)) All property in Jamaica which I may become entitled to as a tenant-in-common with my brothers and sisters as joint tenants



To my grandchildren, Jayda, Nadia and Brandon Simmons my property located on Little Cayman Block 80A Parcel 130 as Joint Tenants and the proceeds of sale of the Vessel Spirit of Tortuga and jet ski which are to be sold with the proceeds to be divided equally among my grandchildren Jayda, Nadia and Brandon.

The following specific bequests are to be paid at the discretion of my Trustees as and when the funds are free and available:

To my General Manager Delrose Williams, the person who is responsible for the growth of Tortuga Rum Company:

The sum of US\$25,000

To Lisanna Gough my good friend and great help to Carlene and myself:

The sum of US\$20,000

To Margeurite Millar the sum of US\$10,000

To my nephew Brian Hamaty:

The sum of US10, 000

To my sisters Sonia Thorn and Helen Furry:

The sum of US\$25,000 each

The Personal certificates of deposits accounts at National Building Society Cayman, numbers 10000015 and 10000867 held in my name shall be divided equally between my Daughter Monique and my son Basil, or the survivor of them. I have no personal financial interest in the remaining certificates of deposit, namely deposit accounts numbered 10000045,10000866,10000865,10000047,10000882,10000 043,10000 057, 10000992,10000046 and 10000048 held in my name and the names of others. My Savings accounts, numbered 20000132, 20000790, 20000791 are to be divided equally between my Daughter Monique and my son Basil, or the survivor of them.

I have no financial interest in the Certificates of Deposit at RBC Royal Bank, Cayman Islands, namely accounts 24503189, 24503191 and 24503192, held jointly in my name and the names of others.. The Certificate of Deposit numbered 24503408 held in my name shall be divided equally between my Daughter Monique and my son Basil, or the survivor of them.



(c) Balance of Personalty

In the event that my Wife, my Son and my Daughter survive me by thirty (30) days, to deliver to my Wife, as her absolute property, my household goods, chattels, furniture and all my effects of personal, domestic or household use or ornament and any automobiles, boats, motors and accessories thereto that I may own at the time of my death, all of the same being hereinafter referred to as "my Personalty". If my Wife shall predecease me or survive me but dies before the expiration of thirty (30) days from my death, then I direct my Trustees to divide my Personalty between my son and my Daughter or the Survivor of them in the event that none of my Wife, my Daughter or my Son survive me for a period of thirty (30) days from my death, I direct my Trustees to divide my Personalty equally among my brothers and sisters equally, or the survivors of them.

(c) Residuary Estate

The balance of any real property comprised in my residuary estate shall be divided equally between my Son and my Daughter as tenants in common. In the event that neither, my Son or my Daughter survive me by thirty (30) days then any real property contained in my residuary estate shall be divided equally among my brothers and sisters or the survivors of them in equal shares as common proprietors.

4. **BENEFICIARIES DISABLED OR LESS THAN 25 YEARS OLD**

Save where expressly provided for in this my Will, if any person should become entitled to an interest in my estate before attaining the age of 25 or being disabled, the interest of such person shall be held and kept invested by my Trustees and the income and capital or so much thereof as my Trustees in their absolute discretion considers necessary or advisable shall be used for the benefit of such person until he or she attains the age of 25. I further authorize my Trustees to make payments for the benefit of any person under the age of 25 (or otherwise disabled) to a parent or guardian in fact or in law of any such person, whose receipt shall be a sufficient discharge to my Trustees.

5. **TRUSTEES' POWERS**

I **AUTHORIZE** and empower my Trustees:

(a) **Conversion and Retention**

To use their uncontrolled discretion in the realization of my estate, with power to sell, call in and convert into money any part of my estate not consisting of money at such time or times in such manner and upon such terms, and either for cash or credit or for part cash and part credit as my Trustees may in their uncontrolled discretion decide upon, or to postpone such conversion of my estate or any part or parts thereof for such length of



time as my Trustees may think best. No reversionary or future interest shall be sold prior to falling into possession, and no property not actually producing income shall be treated as producing income. I further authorize and empower my Trustees to retain indefinitely any portion of my estate in the form in which it may be at my death (notwithstanding that the same may not be in the form of an investment or investments in which Trustees are by statute authorized to invest trust funds, and whether or not there may be any liability attached thereto) for such length of time as my Trustees may their absolute discretion deem in the best interests of my estate and any portion of my estate so retained shall be considered as an authorized investment for all purposes of this my Will.

(b) Investments

To invest monies of my said estate (including monies from any sale or conversion arising in my estate) in any investment or investments which my Trustees shall in their absolute discretion deem advantageous to my estate, but being limited to investments in which Trustees are by statute authorized to invest trust funds and in like manner from time to time to alter or vary such investments.

6. SECURITIES

**I AUTHORIZE AND EMPOWER** my Trustees to deal with any securities, shares or other interest of or in any syndicate, organization, company or corporation which shall be from time to time held by my estate

or by any trust fund created pursuant to this my Will, to the same extent and as fully as I could if I were alive, and without limiting the generality of the foregoing, to take up new or further shares, rights and interests to join in plans for reconstruction or reorganization, to exchange shares, rights and interests and to give, receive, accept and exercise options and to pay out of my estate any monies which may be necessary for any of the purposes aforesaid. I further authorize my Trustees to retain as an investment for my estate for such length of time as my Trustees considers advisable any stock dividends received in connection with any shares of stock from time to time held by my Trustees.

7. **CORPORATIONS**

Without limiting the generality of the foregoing, if at any time my Trustees hold in my estate any investments in connection with any Company or Corporation I authorize my Trustees:

- (a) to join in or take any action, or to exercise any rights, powers and privileges which at any time may exist or arise, in connection with it to the same extent as fully as I could if I were alive and the sole owner of the investment;
- (b) to retain as an investment of my estate for such length of time as in their discretion my Trustees deem advisable, any assets or other interest whatsoever required by my Trustees throughout the exercise of the powers hereinbefore given;



- (c) to sell, assign, transfer or deal with any shares or interest in any Company or corporation in accordance with any agreement, which I may have entered into;
- (d) to form or join in forming a limited company for the purpose of taking over or purchasing the whole or any part of any such business or businesses or to sell the same to a limited Company at such price and subject to such terms as my Trustees in their discretion may determine and in consideration for any such taking over or sale, power to accept cash and bonds and notes and preference shares and common shares of any Company whether or not such Company is the Company taking over or purchasing as aforesaid, or all or any of the aforesaid as my Trustees in their discretion may think fit and so that any bonds and notes and preference shares and common shares so received shall, notwithstanding anything in my will to the contrary provided, constitute an authorized investment thereunder.
- (e) And further power, out of the monies forming part of my estate, to subscribe for and purchase the shares, debentures or other evidences of any such Company and to loan monies to any such Company;
- (f) To reorganize, reconstruct or concur or join in any scheme or arrangement for reorganizing or reconstructing any Company or Companies in which I may hold shares or securities at my death and for such purpose to take or concur or join in any necessary

proceedings to wind up any such Company or Companies and to cause a new Company or companies to be incorporated and for any such purposes to apply such part of my estate as my Trustees shall in their discretion deem expedient.

- (g) My Trustees may also surrender or exchange shares or securities in any of such Companies in return for new or other shares in such or any Companies that may be formed for taking over their assets upon such terms as may appear expedient and in general, deal with all shares and securities in any way that my Trustees shall in their discretion deem conducive to the reorganization or reconstruction of any such Companies and the interests of my estate. For all such purposes, all shares and evidences of indebtedness in such new or reorganized or reconstructed Companies shall (notwithstanding anything in my Will to the contrary provided) constitute an authorized investment thereunder;
- (h) to loan to any company in which my Trustees may own voting shares any monies from my estate with or without security as my Trustees in their discretion may see fit;
- (i) to appoint any one or more directors (where otherwise so enabled) or any Company or other organization to fill any vacancy caused by my death.

All powers pursuant to this paragraph are discretionary and not mandatory.



8. **ELECTIONS**

I GIVE to my Trustees absolute direction from time to time and at any time or times to make or not to make any election or elections, determinations, distributions and/or allocations as they in their absolute discretion deem to be in the best interests of my estate and/or the beneficiaries, whether or not such election or elections, determinations, distributions, and/or allocations may or would have the effect of conferring an advantage on any one or more of the beneficiaries or could otherwise be considered but for the foregoing as not being an impartial exercise by my Trustees of their duties hereunder or as not being the maintaining of an even hand among the beneficiaries. Where any specific funds, shares or residue are created under this my Will my Trustees shall have the absolute power to determine which specific assets shall form such fund, share or residue, as the case may be, unless otherwise expressly provided in my Will. I specifically exonerate my Trustees from any responsibility with respect to any such elections, determinations, distributions and/or allocations if my Trustees act bona fide in the exercise of such power.

9. **DISTRIBUTION**

MY TRUSTEES may make any division of my estate or set aside or pay any share or interest therein, either wholly or in part, in the assets forming my estate at the time of my death or at the time of such division, setting aside or payment and I expressly will and declare that my Trustees shall in

their absolute discretion fix the value of my estate or any part thereof for the purpose of making any such division, setting aside or payment and the decision of my Trustees shall be final and binding on all persons concerned. I specifically direct my Trustees to make any distributions of the assets forming my estate solely in the Cayman Islands.

10. **SUBSTITUTION**

**MY TRUSTEES** shall have vested in them the power of appointing new Trustees and any Trustees of this my Will shall have the power to retire as Trustees and such power as aforesaid shall be exercisable by Deed or Deeds and my Trustees may appoint a new Trustee or Trustees within the Cayman Islands exclusively as Trustees hereof. Upon any such power of appointment of new Trustees being made, my substituted Trustees shall immediately stand possessed of my estate upon trust for the new Trustees, and shall transfer the same to the new Trustees as soon as possible, so that my estate shall continue to be held upon the trusts hereof, but subject to and governed by the Law of the Cayman Islands.

11. **JURISDICTION**

**I DECLARE** that this Will and the trusts hereof shall be read and take effect in accordance with the Laws of the Cayman Islands and the rights of all persons and the construction and effect of each and every provision hereof shall be subject to the exclusive jurisdiction of and construed only according to the laws of the Cayman Islands, the Courts of which shall



become the forum for the administration of this my Will (but so that, nonetheless, my Trustees may by deed declare that the trusts hereof shall continue to be read and take effect according to the Laws of the Cayman Islands).

12. **INTERPRETATION**

IN THIS MY WILL the following terms shall be defined as having the following meanings:

- (a) **"disabled" or "disability"** as applied to any person shall, unless otherwise specified, mean any disability, which the Trustees, in their sole discretion, shall determine, exists at any time. The exercise of the foregoing discretionary power shall be binding and conclusive upon all persons interested in this Will
- (b) **"Issue"**: Whenever the word "issue" appears in this my Will, it shall mean any child or children of any deceased child of mine or, where applicable, any child or children of any deceased grandchild of mine.
- (c) **"Net"** means proceeds less the reasonable costs of administration, recovery, sale and/or distribution
- (d) **"Wife"** means Carlene Hamaty

13. **CHILDREN BORN OUT OF WEDLOCK**

Save and except for any individuals specifically named herein, any reference in this my Will or in any Codicil hereto to a person in terms of a relationship



to another person determined by blood or marriage shall not include a person born outside marriage nor a person who comes within the description traced through another person who was born outside marriage, provided that any person who ~~has been~~ legally adopted shall be regarded as having been born in lawful wedlock to their or her adopting parent and any person who is born outside marriage and whose natural parents subsequently marry shall be regarded as having been born in lawful wedlock.

14. **BONA FIDE EXERCISE OF POWERS**

I HEREBY EXONERATE my Trustees from any responsibility or liability or loss or damage which may be occasioned to my estate through a bona fide exercise by my Trustees of any of the powers and discretion hereinbefore vested in same.

15. **HEADINGS**

The headings of the sections of this my Last Will and Testament are inserted for convenience only.

16. **GENDER AND NUMBER**

In this my Last Will and Testament, any reference to the male gender includes the female and vice-versa; any reference to the single member

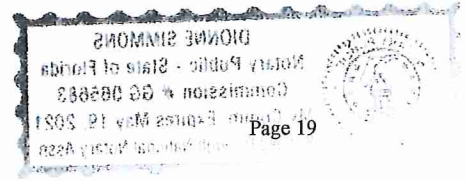

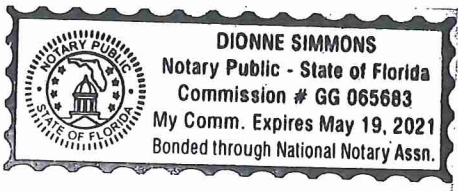
