**THIS PLAINT** has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after service of this Complaint on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out full particulars of your defence in the space provided in the Acknowledgment of Service form.

If you fail to satisfy the claim or to return the Acknowledgment of Service form containing full particulars of your defence, the Plaintiff may apply for a default judgment without any further notice to you.

## PARTICULARS OF CLAIM

---

1. The Plaintiff is and was at all material times a company organised and carrying on business pursuant to the laws of the Cayman Islands. The Plaintiff's address for service is care of its attorneys, HSM Chambers, 68 Fort Street, P.O. Box 31726, Grand Cayman, KY1-1207, Cayman Islands.
2. The Defendant is an individual who resides in the Cayman Islands with a mailing address of P.O. Box 12409, Grand Cayman KY1-1011, Cayman Islands.
3. The Plaintiff's business involves the supply and delivery of concrete, mortar, cement and other similar products. At all material times, the Plaintiff would deliver concrete to a location at the request of the Defendant, and upon delivery provide a delivery slip and then submit an invoice subsequently for the payment for the goods and services rendered. There was no formal contract drawn between the parties to govern the facility by which credit was so advanced.
4. In December 2017, the Defendant, purchased concrete from the Plaintiff for which the Plaintiff produced sales receipts as follows (collectively "the invoices"):
  - i. On 22 December 2017 – Invoice Number CPL20172212 for CI\$7,774.00; and
  - ii. On 29 December 2017 – Invoice Number CPL20172912 for CI\$649.50.

The total amount due under the Invoices was CI\$8,423.50. The Statement detailing the invoices from these transactions are exhibited at "**POC1**".

4. The Defendant presented the following cheques in consideration for the purchased goods at point of sale (collectively "the Cheques"):
  - i. a Butterfield Bank (Cayman) Limited Cheque No. 236 for CI\$7,730.00 dated 20 December 2017 in his name, which was applied to Invoice Number CPL20172212 for CI\$7,730.00 ("Cheque No. 236"); and
  - ii. a CIBC First Caribbean International Bank Cheque No. 56 for CI\$649.50 dated 21 December 2017 in his name, which was applied to Invoice Number CPL20172912 for CI\$649.50 ("Cheque No. 56").

Exhibited as "POC2" are copies of the Cheques and payment receipts.

5. The aforementioned Cheques were subsequently dishonoured by the Defendant's bank which, in accordance with section 47 of the *Bills of Exchange Law (1997 Revision)* ("the Law"), also provides an immediate right of recourse against the drawer in addition to damages for breach of contract.
6. Further, the Plaintiff suffered loss and damage when it incurred a bank return fee of CI\$45.00 for the dishonoured Cheque.
7. The total amount due under the Invoices was CI\$8,423.50.
8. The delivery slips contained, *inter alia*, the following terms on the reverse:

*"If it becomes necessary to bring any action to collect amounts due on this invoice, Purchaser shall be responsible for reasonable attorney fees and court costs incurred by vendor in securing collections. Interest shall accrue at 2% per month on outstanding balances".*

9. The Defendant has failed or neglected to make full payment of the sums due in respect of the Invoices notwithstanding being sent a demand letter on 4 December 2018, via email.
10. As at the date of this Plaint, the Defendant owes to the Plaintiff the principal sum of CI\$8,423.50 together with interest at the rate of 2% per month from 1 January 2019 to date.
11. Alternatively statutory interest pursuant to Section 34 of the *Judicature Law (2017 Revision)* and the *Judgment Debts (Rates of Interest) Rules, 2012* at the rate of 2.375% and continuing at the rate of CI\$0.55 per diem for such a period as the Court deems fit.
12. As a result of the above, the Plaintiff is entitled to the relief claimed in these proceedings.

**AND THE PLAINTIFF claims:**

- a) CI\$8,423.50 being the principal sum due;
- b) Pre and post judgment interest from 1 January 2019 to date in the sum of CI\$4,259.29 and continuing at the rate of CI\$5.54 per diem, at the rate of 2% per month in accordance with the terms of the invoices;

- c) Alternatively, Pre- and post-judgment interest pursuant to Section 34 *Judicature Law (2017 Revision)* and the *Judgment Debts (Rates of Interest) Rules, 2012* at the rate of 2.375% and continuing at the rate of CI\$0.55 per diem;
- d) CI\$175.00 fixed costs pursuant to Section 11 of the *Summary Court Rules, 2004*; and
- e) Such further and other relief as this Court may deem just.

## INDORSEMENT

The principal amount claimed in respect of the debt is CI\$8,423.50 as of the date of filing. The amount of the filing fees to commence the proceeding is CI\$25.00 together with a claim for fixed cost of CI\$150.00 upon commencement of a claim. If, within the time for returning the acknowledgement of service, the defendants pay the plaintiff or its attorneys-at-law the total amount claimed in principal and the costs of issuing the Plaint, further proceedings will be stayed. The money must be paid to the plaintiff or to its attorneys-at-law.

## INDORSEMENT REGARDING INTEREST

1. The contractual term upon which interest is claimed is as set out in paragraph 8 above.
2. The prescribed rate of interest is 2% per month.
3. The date from which interest is payable is from 1 January 2019.
4. The amount of interest accruing due each day is CI\$5.54.
5. Alternatively, pre- and post-judgment interest in accordance with Section 34 *Judicature Law (2017 Revision)* and the *Judgment Debts (Rates of Interest) Rules, 2012* at the rate of 2.375% and continuing at the rate of CI\$0.55 per diem.
